

Declaration of Aaron Surina

1. I Declare: I am the Respondent and make this declaration in response to the declaration filed by the petitioner on 01/12/2018.

These motions by the petitioner and her team seem to be an attempt to distract the court from the very serious nature of the contempt I filed regarding child neglect (RCW 26.44.020) and the petitioner concealing from me, the court and the children's primary care providers the fact that our children were living in a house with active Tuberculosis for 5 months. As reported by the Spokane Regional Health District Tuberculosis Management Nurses: "The Petitioner refused testing of the children," chose to not inform anyone, or schedule a test with their primary care physicians despite "being encouraged by the Public Health Nurses for 5 months, and they could not force her."

I have motioned the petitioner into court because of a clear court order from the commissioner that was given with an interpreter which was clearly and willfully ignored. 5 times the petitioner chose to not follow the court order and removed me from the healthcare decisions of my children. In response to the motion of the willful disregard for clear orders from the court, I have now been served with a motion for a restraining order to remove me from the healthcare of my children.

Declaration of Aaron Surina - In response to petitioners declaration and motion for restraining order

2. The petitioner's statements are false. There was never agreement with selling the house. I was informed that the petitioner did call my realtor and told her "she was ready to list the house."

We have civil restraints so we have made no progress towards any productive discussion.

I have a motion to compel the answers to the interrogatories before the court. The abuse of civil process in an attempt to perpetrate fraud in this case is appalling.

Mediation was refused. Mr. Glanzer sent the message they would consider any attempts at mediation "harassment" when I requested mediation around the beginning of October.

(SEE EXHIBIT A)

The petitioner believed that she could immediately sell the house in August after filing this case. She packed up the entire house into boxes in August. The children's toys are boxed up and the house is void of even the wall art.

I did not ask the petitioner to do any repairs to the house. We have had no identification of assets and investments in Thailand as well as in America yet. No discussions have taken place regarding how those proceeds would be divided or returned to me/her or split.

The community property that's been invested into the Rocky Ridge property is not being disputed at this time however it has not been calculated. I have not received the answers to the interrogatories, which will have a huge impact on the financial division of estate and assets.

This request to sell the property is premature since we have not been to mediation nor have we even received the answers to the interrogatories. We have made investments in Thailand for over 5 years. None of those assets have been listed, valued or discovered within this court yet.

I received an email from my realtor regarding "Carl Wilson calling on behalf of Keith Glanzer stating that Keith wanted to know when and if I had drawn up papers to sell the house." This behavior further illuminates the intent of the Wilsons and the petitioner to perpetrate fraud in pursuit of gaining financially. I have the audible voicemail as well as transcripts of the phone call.

The statements that I "changed my mind" about selling the house are misleading and willfully made in an attempt to deceive the court. The house is the last thing I intend to sell based on disclosure of investments Declaration of Aaron Surina – In response to petitioners declaration and motion for restraining order

and other assets that I feel are being hidden in an attempt to keep the proceeds and not honestly divide what is rightfully community property.

I do ask that the court use the judicial power of contempt to curtail the massive amount of perjury and willful submission of false statements in attempts to deceive or mislead the court on the matters in this case. I ask that mediation be ordered to begin the discussion process and that a 3rd party mediation company is used rather than counsel chosen individuals. I also ask the court to deny ordering me to pay the petitioners legal fees.

This entire case has been riddled with the willful intent to mislead the court. I'd like the opportunity to complete discovery, receive and discern the answers to the interrogatories, and continue due process. I'd also like to give the opportunity to opposing counsel to remediate the statements that he now knows are false that he has submitted for the petitioner as Civil Rule and Candor of the court calls ethics before client's pursuits. I am asking this in relation to USC 18 1623 (d). There are many statements that opposing counsel (Keith Glanzer PS) knows to be false and has not remediated as of this date. THIS IS HIS OPPORTUNITY TO CORRECT HIS ETHICAL POSITION.

3. My hours in the current parenting plan do not allow me to have any regularly scheduled pediatric appointments or dental appointments. The children's dentist has the last appointment at 2:40pm. I couldn't have the children to an appointment until 4pm in the afternoon with the current parenting plan.

There currently is not an available slot for me to bring David into see Crystl Murray Mills until March due to the parenting plan and my limited time with the children. After the court ordered Crystl Murray Mills, I contacted her to try to schedule an appointment but none were available. I explained my parenting plan and I came in and met with her and when the petitioner found this out, they immediately went as well.

I expressed my concern for the wellbeing of my children. I expressed that I have been trying to get a Guardian Ad-Litem for 5 months to no avail. I asked her to help me with this process. She made herself available on Saturday to see David. The petitioner went to the counselor on her own visit and told the counselor that "she can't talk to him and had to have Carl Wilson talk for her."

 $Declaration\ of\ Aaron\ Surina-In\ response\ to\ petitioners\ declaration\ and\ motion\ for\ restraining\ order$

The children's dental needs have been neglected since August. I have made calls to their dentist to find out if I could get the children in for their exams but to no avail they have no appointments that late in the afternoon (after 4pm).

Any co-parenting is considered a hostile environment for Sirinya Polarj (the petitioner). She is easily frustrated with a wellness visit questionnaire and is unable to fill out the simple questionnaires which are vital in assessing the health of our children at a wellness visit.

January 2, 2017: We met at the pediatrician's office. Sirinya stated, "He's not the parent of my children, he only gets to see them 4 days a month." She was unable to complete a separate 18 month old questionnaire for Andrew's wellness visit. She became very frustrated, clearly upset and Dr. Carlson advised her that we could all work on it together.

I did not speak to Sirinya because of the court order and the irrational means in which they have continuously bullied me in court thus far. Sirinya became extremely agitated upon the Doctor looking at injuries on my son David's chest by. She became upset was not because of me, but because **David revealed to the Doctor that his mother had caused the injuries**. David's chest had gouges, lacerations and horizontally crossing claw marks on his chest which were noticed while we were all swimming at the Kroc Center.

(SEE EXHIBIT B).

These same injuries I know and am familiar with from my own experiences of the petitioner's physical violence towards me, including deep bruising on my body (SEE EXHIBIT C), scratches on my face, arms and more. (SEE EXHIBIT D). Being a male victim of battering carries stigma, shame and the inability to seek assistance due to disbelief.

We recently noticed the claw gouges on David's arm on Christmas morning identical to Exhibit D. (SEE EXHIBIT E [in comparison to EXHIBIT D])

David was brave enough to speak to the doctor and shared that his mother, who drove him to the appointment, had attacked him and was the aggressor / perpetrator of the claw mark / lacerations and gouges on his chest. He pointed at the petitioner, and told the doctor that the injuries were from his Mother. In response, the petitioner to yelled at our son David, and insisted that scratches were caused Declaration of Aaron Surina – In response to petitioners declaration and motion for restraining order

from someone else. She the reminded the doctor of Andrew's black eye (SEE EXHIBIT H) and stated how "a toy caused the black eye." While I was living in the residence, I was able to protect my children by acting as a buffer, taking her physical attacks, buying her expensive gifts, "agreeing" to invest in Thai investments, cleaning the house, taking care of the kids and doing all I could to de-escalate her rages.

The petitioners team has recently learned of RCW 26.44.030 through my filings which are being heard today and which I believe is the another reason they are attempting to remove me from the healthcare of my children. (RCW 26.44.030 Mandatory Reporters of abuse / Licensed medical staff).

My son came home one day, returning from the grocery store with his mother. He was coughing up blood and I was petrified when I saw his condition upon their return. My co-worker was at the house helping me move furniture that evening. (Christopher Polito). Sirinya, the petitioner, said he was "picking his nose and that's how he was all bloody." I've attached photos of this incident where I had to get on the phone with Pediatric Emergency Afterhours, seeking care and getting medical advice about my son coughing up blood. (SEE EXHIBIT F). That phone call could not have been made by the petitioner. She could not navigate an emergency with the children, nor would she know the number to call to evaluate with a live emergency after hours nurse.

My obvious concern is that an attempt to remove me from the healthcare of my children is an attempt to conceal further abuse and injuries to the children.

Furthermore, The petitioner did not take my children in for a single dental visit in the last 6 months. I have all of our dental exams scheduled at the end of the year. She did take herself in and take care of her teeth and sent me the bill. I did pay the bill for her when I received it hoping to see something for the children at the end of 2017. I called the dentist, she never called or made any appointments for the children. She did take herself to have her teach cleaned, examined and taken care of.

My son David currently has been complaining of a cavity and cringes often while eating which is very noticeable. The petitioner has made no attempt to take care of his teeth including forfeiting 2000.00 Declaration of Aaron Surina – In response to petitioners declaration and motion for restraining order

dollars worth of health coverage for both Andrew and David which is only available until end of 2017.

Had the children been in my placement, their dental and health care needs would be addressed.

I have been the parent who has taken care of all of the healthcare needs of my children and my spouse prior to August 2017. All appointments, women's health, pediatric and pediatric dentistry, prescriptions, OTC medicine, dispensing proper dosage, temperatures etc. The petitioner would email me when she was concerned about the children's condition because she did not know what to do. (SEE EXHIBIT G). It seems that she only is concerned about herself and her mother's healthcare. Note that I filled out the questionnaire they attached to their filing, and documented that it's only for my 2 weekends a month, and the majority of time the children are with their mother. At this time and she should fill out a questionnaire of her own to give more valid input into the daily lives of the children and how she maintains care.

David shared that he was told that "he would be put in jail if he did not tell people exactly what he was told to say." This is red flag to me and while broken down one night on the side of the freeway, I spoke to Idaho State trooper John Kempf and asked him to assure David that policemen don't take 5 year old kids to jail and that policemen help us. David was visibly scared when the trooper pulled up to help us. We explained that police are helpful and there to keep us safe. This is in stark contrast to a 5 year old six months ago that wanted to be a Sheriff like Ozzie Knezovich, whom I volunteer with on Search and Rescue, and speak highly of regularly around my son so that he respects the rules of law.

Providence is my place of employment and to suggest that I would cause discomfort or any type of a hostile environment is absurd. (SEE EXHIBIT I).


I ask the court to dismiss the Motion to sell the residence and dismiss the motion to designate the petitioner as the sole decision maker for healthcare. The claims that I make the medical staff upset as well as blaming me for how she feels when faced with the reality of what she has been doing to my children are baseless. I feel they are trying to bully me as a pro se litigant. I can't even afford a lawyer at this point due to the vexatious litigation that has been launched at me in an attempt to take the children from me without a single shred of evidence that warrants such a legal ruling. I ask the court to deny any Declaration of Aaron Surina – In response to petitioners declaration and motion for restraining order
