**REPLY DECLARATION OF:
SIRINYA SURINA RE: RESPONDENT'S
RESPONSE OF PETITIONER' MOTION
FOR CONTEMPT**

Sirinya Surina Declares:

1. I am the Petitioner and mother of David and Andrew Surina;
2. Refusal of testing for Children. Respondent fails to provide the court or me with records from the SRHD to support his claim. Please see Dr. Lutz' letter filed herein.
3. Interpreter/clear and willful ignore. The court appointed interpreter was not seated in a position where the Petitioner could ask questions of her or hear comments about the proceedings. The Interpreter left early due to another commitment and said she would get back later to go over her notes. That didn't happen.
4. Mrs. Wilson helped me understand most of the proceedings but didn't have notes nor was her help "real-time" during the proceedings to keep everything in perspective.
5. Mrs. Wilson is not a "certified translator" which the Respondent is now insisting on for any translation help in the children's health-medical appointments. He deems her ability to be inadequate. So, I will require a "certified" translator from now on.

- 1 6. Sale of Residence. Aaron verifies he was working with a realtor regarding
2 the sale of our residence. It is my understanding that she came out to look at the house
3 after she talked with Aaron.
- 4 7. Mediation. The Temporary Parenting Plan ordered November 8, 2017 names James
5 Hatch or other qualified provider. I agree to mediate with James Hatch pursuant to the
6 Court's order to mediate. I do not agree to Fulcrum Institute. I do not agree to appear at
7 mediation without my attorney.
- 8 8. Hospital ER and CPS. Aaron's justification for taking Andrew based upon David's
9 statement (5 years old) fits into his narrative that I am an abuser and the court should
10 place our children primarily in his care. This is part of what he previously posted on his
11 instagram account that he will do whatever it takes to gain placement and invited his
12 followers to watch because this is "how a man does it."
- 13 9. "David says." Aaron admits to discussing our legal proceedings with David and more likely
14 than not is coaching him to make accusations that have now risen to the level where David
15 is reporting that a "man hurt him" and "my butt hurts." I hope his counselor can help David
16 and get to the bottom of these allegations. I believe it is his father coaching him. Aaron
17 has taken the children multiple times for medical examinations.
18 (Respondent and Petitioner) agreed to provide money for a drainage system at my
19 Grandmother's home to make it more livable to western standards for Aaron and the
20 children. The total cost was less than \$500 US dollars. It was a gift to Grandmother for our
21 comfort, it was not an "Investment." I own no property in Thailand and Respondent can not
22 own property in Thailand.
- 23 11. Wilson Investments. The Wilson's have no "investment" in this case. They will receive no
24 benefit of financial growth or other monetary benefit, whatsoever.
25 Although Respondent is trying hard, the Wilson's are my only friends in this locality that
the Respondent has not been able to bully or threaten and drive away from me.
Aaron has methodically, for years succeeded in isolating me and alienating anyone who
got close enough to me to become my friend, in all the locations we have lived.
12. Wilson contact with Realtor. Mr. Wilson called Aaron's Realtor at my behest. My Attorney
counseled me that it is time to talk about what will happen to the house. If Respondent
doesn't want to sell, I'm OK to live here indefinitely.

- 1 13. Health/Dental Care. I am the one who normally takes the children to medical
2 appointments. Sometimes we both go but mostly it is me, alone.
3 It has been only 5 months since the children's last dental exam. I believe our dental
4 insurance does not cover more than 2 non-emergency dental exams per year. David has
5 not complained to me about tooth pain but he does have one loose baby tooth. February
6 should be the next scheduled routine exam, if David complains about pain, I will take
7 him in right away.
- 8 14. Counseling Appointments. David now has regular scheduled appointments with his
9 counselor. However, I also had to wait some weeks for an opportunity to begin those
10 sessions. I make my own decisions, Aaron is attempting to belittle me because I don't
11 have a solid grasp of the English language and when I ask my friends for help in
12 understanding and expressing myself with government, legal and medical personnel.
13 Aaron has little understanding of how difficult it is to live in a place where one has difficulty
14 with the local language. His short visits to Thailand were initially with friends and in tourist
15 areas where most of the population has a working knowledge of several "tourist"
16 languages. Later, I helped him when he visited my families' home, which is far from tourist
17 areas. He should remember how lost he was. He couldn't even get a drink of water by
18 himself. If he were in a legal situation there, he wouldn't be able to navigate even the
19 phone to call for help.
- 20 15. Respondent has put so many condescending misleading statements in this document
21 about my Attorney, Friends and me but I believe the Court will see through his false
22 statements.
- 23 16. Respondent took all information and documentation from the house as to insurance
24 and medical appointments. While I was still thinking we were a "family," I trusted him to
25 make the appropriate appointments. I took the children to the appointments. However,
once I found out he was putting his plan in place to divorce me, I stopped trusting him.
Aaron often does not tell the truth. He makes up stories to support his agenda.
17. Nose Bleed. I took David shopping with me while Aaron and his friend stayed home
playing and drinking beer. When I returned, David ran to the bathroom. While in the
bathroom, he picked his nose and it started bleeding. He called out to me and I went to

1 help him. David had blood all over his face, mouth and shirt. I laid him on his back and
2 called out to Aaron who became "Petrified" except he was able to take several photos of
3 the incident. When the blood ran down David's throat from the back of his nose, he
4 swallowed some causing him to cough and vomit. I yelled out for Aaron to call the doctor.
5 Finally, Aaron got hold of the doctor who told us to have David cough a few times more to
6 see if more blood came up. It didn't, the coughing was clear. We didn't have to go to the
7 doctor's office. The whole time, I was taking care of David while drunken Aaron and his
8 drunken friend stood around taking pictures, making derogatory comments and not
9 helping. Please note that Aaron's Exhibit shows that I am the one taking care of David.

10 18. Limit Healthcare Decisions. I am asking the court to remove Aaron from making joint
11 health care because he negatively impacts the doctor's appointments. He has made
12 medical personnel uncomfortable and he coerces David to lie for him.

13 19. Aaron belittles me for my lack in speaking the English language. Aaron fills out the pre-
14 appointment questionnaire, on line prior to going to the doctor. He expects me to fill out a
15 paper questionnaire in 15 minutes while he is bullying me, yelling at me and without
16 translator help. The doctor tried to tell him it was OK and that he would just ask me the
17 appropriate questions. That was not good enough for Aaron. He kept badgering me trying
18 to start a fight in the doctor's office. The doctor had to intercede.

19 20. At the next appointment, on Wednesday, January 17, I took my friends to help me
20 translate but Aaron wouldn't let them come into the office. The doctor's office supervisor
21 talked to Aaron and asked him if he was going to give them any trouble on today or if he
22 could behave himself. She said if he didn't behave, he would have to leave. This time, the
23 doctor got a telephone translator for me. It took a little longer but it was OK. Then he
24 allowed each of us to be in the exam room but only one at a time. So while he was with the
25 doctor, he tried to blame me for causing all the bruising and scratching that David obtained
while snowboarding with Aaron the past weekend. When Aaron told the Doctor David had
complained to him about a "man hurting his bottom" the Doctor reported the information to
CPS. Please see Exhibit A, a true and correct copy of Doctor Maixner's 1/17/18 medical
record. However please note that the doctor reports that any bruises he had were from
snowboarding as reported by David.

3 In conclusion, I am asking the court to find Aaron in contempt for continually taking our
4 children to doctor's appointments. I am also asking for Aaron to be removed from the
5 joint decisions for health care on the parenting plan because at every visit I make, I notify
6 him and he shows up there and creates a very hostile situation which makes the medical
7 staff and the children and me very upset. I have incurred additional attorney fees and ask
the court to award me \$1,500.00 in attorney fees.

8 I declare under penalty of perjury under the laws of the state of Washington that the
foregoing is true and correct.

HPI: David Michael Surina is a 5 y.o. male being seen today for the following concerns:

- Unknown very difficult social situation. Mother and father are in the midst of a very difficult divorce. This child comes in today with bruises on his arms and legs and mother is concerned that either the father has harm the child with that he will accuse her of harming this child. When questioned about the bruises David states she got it going to Silver Mountain snowboarding this last weekend. He states nobody has hurt him regarding these bruises. He thought snowboarding was a lot of fun.
- Father is concerned because the child has complained of some rectal pain and some bleeding. Father states that David has told him that there is a man who has hurt his bottom. This has been reported to child protective services. Other wish for me to take a look.
- Patient has a lot of allergies and some eczema.

Review of systems: negative except as noted above in HPI

Current Problem List:

Diagnosis

- BMI (body mass index), pediatric, 95-99% for age
- Environmental allergies

Medications: reviewed and updated in chart.

Allergies: reviewed and updated in chart.

Past Medical History: Past medical and surgical history were reviewed in the appropriate locations in the chart and updated.

Exam: Temp 37.2 °C (99 °F) (Temporal) | Ht 1.2 m (3' 11.25") | Wt (!) 32.4 kg (71 lb 6 oz) | BMI 22.48 kg/m²

Gen: The physical exam is generally normal. Patient appears well, alert and oriented, pleasant & cooperative. Vitals reviewed.

HEENT: PERLA. Mucous membranes moist. Pharynx clear. Tympanic membranes benign. Nares patent.

Neck: supple with no significant adenopathy.

Lungs: clear to auscultation. No work of breathing at rest.

Heart: Regular in rate and rhythm. No murmurs.

Abdomen: soft, no tenderness, bowel sounds are normoactive

Extremities: Capillary refill brisk. Peripheral pulses are normal.

Neuro: Moves all extremities, equal tone, appropriate for age

EXHIBIT A.

Skin Scattered eczema with obvious signs of this child's scratching at himself. He does have several bruises on both his forearms and his shins. No bruises or detected on his back and abdomen around his buttocks her face..

GU: Normal male external genitalia.

In examination of his rectal area. There is a ring of inflammation with several small lesions that could be called tiny pustules on his buttocks.

I see no signs of trauma this time there is no bruising. There are no rectal tears.

ASSESSMENT & PLAN:

The bruising would be very compatible with the child's physical activities his last weekend. He states as for the bruises came from. He seemed very calm and discussing that.

Child protective services will need to investigate story of possible abuse. I have no physical signs of abuse at this time. He does have eczema and his physical findings would be compatible with a perirectal infection, most commonly Streptococcus. I will treat this with Keflex for 7 days.
