

Sirinya Surina Declares:

- 1. I am the Petitioner and mother of David and Andrew Surina.
- 2. Police Statement Respondent does not recall the police telling her "Respondent was not breaking the Court's Parenting Plan orders."
- 3. Alienation of Children: Aaron looks for each and every opportunity, even small occurrences in the life of boys, to blame me for abuse of our children. Aaron constantly returns the boys from his visitation, covered in rashes, bumps and bruises, ill fed, thirsty and mostly very hungry. He also coaches David to tell lies about how their little bumps and bruises occurred and tries brainwashing him that he has a bad and stupid mother. I don't make a big scene about the way they return. I just bathe the boys and put on medication for the rashes. I feed their hungry tummies something more substantial than donuts, pizza and cheeze puffs. At home, we seldom make a point of talking about Aaron

and when we do it is not in a derogatory manner. I always try to prepare them to have fun with their father and when they return and tell me what they did, I give them positive feedback if they enjoyed their visit. If they are apprehensive to leave for a visit with him, I tell them I will be here when they come home, not to worry. Unfortunately, Aaron does not do the same. He is focused in his agenda to destroy me, destroy the relationship with my children and alienate me from them. As he points out with his texting, he is trying to destroy the peace and happiness of the children and me, and the harmony in our home. "I'm closing yup all the smile gates around here, slowly" and "plotting worse than the best Tweakers" because he's "skilled."

- 4. It's not in his nature to compromise. He has been uncompromising during most of our relationship, which has made me more stubborn, as well. But I always put my children's happiness and needs first. I do compromise. For example, when Aaron asks for special extensions of child exchange time so David can finish his swimming at their new club.
- 5. Staging confrontation. I have some of Respondent's videos from our desktop computer that clearly show him setting the stage before he begins his attacks on me. Most of my videos where I tried to counter his videos were deleted from my phone when he physically grabbed it from my hands and ran off to some other place in the house. He didn't return my personal phone for several hours. He not only deleted my personal media but, as I found out later, installed key-loggers and spyware on my phone, setup GPS tracking, then browse my entire private files on Google and Social Media. Later he setup several cameras and recorders to electronically watch me. Please see Exhibit B, which contain true and correct pictures of various cameras I found in our house.
- 6. <u>Setting up counseling</u>. I went to counseling, but Aaron had already given his opinions and the counselor said we could no longer attend counseling together because Aaron couldn't control his temper. Just like the way he acted in Dr. Carson's office and the Spokane Regional Health Department office.
- 7. Wilson's relationship to family. Mr. Wilson doesn't talk about this case to David. Mr. Wilson is not trying to be my son's Dad. They do call him "Uncle" and like to have him and Mrs. Wilson come and watch TV with them. The Wilson's have been friends of my family for about 4 years, they were Aaron's friends also until they saw the massive abuse that

Aaron was heaping on our family. As soon as Aaron realized that they knew the truth, he tried to shut them out and is still trying to bully them away from me.

- 8. <u>Decision Making</u>. Neither Mr. Wilson nor my Attorney, who does advise, makes decisions for me. I make my own decisions. This is another lie. This is Aaron trying to bully and belittle me again and say to the Court that I am a stupid person, unable to function without someone else telling me what to do. I agree that I do need a stronger grasp of the English language, and more education to prepare me for the job market but I'm very capable of taking care of my children and running my household. When I came to America, Aaron was making less than \$12,000 dollars a year. Working together and with my support and maybe a little push for him to do better, he is now making about \$110,000 a year.
- 9. <u>Court Order</u>. I am asking the court to appoint a GAL, order Aaron to pay \$15,000 in attorney fees. Please note he has used community funds to pay his attorney while I had to borrow the money from the Wilson's. Also, the court should order that our residence should be put on the market. The payment for family expenses could be reduced dramatically if we sold our residence and both of us relocated.

I declare under penalty of perjury under the laws of the state of Washington that the foregoing is true and correct.


