#### Sirinya Surina Declares:

- 1. I am the Petitioner and mother of David and Andrew Surina;
- 2. Investigation of sex crimes to minor children. Respondent misleads the court when he suggests that my friend Carl Wilson is currently under investigation for sex crimes. It is true that Respondent and his sister, Karmen Colby, have tried to get medical professionals to create a record by working on our son, David to make untrue statements. However, the medical records he submitted to the District Court are primarily Respondent's statements about what David supposedly said to Respondent. #### **FINDINGS**

## The Court finds based upon the Court Record:

- A. The Court has jurisdiction over the parties, the minors, and the subject matter and Respondent was provided with reasonable notice and an opportunity to be heard.
- B. Notice of this hearing was served on the Respondent by: Personal Service.

## The Court is unable to find by a preponderance of evidence that:

1. Respondent engaged in a course of conduct directed at Petitioners; there is also insufficient evidence for the court to find that the Respondent's actions were unlawful or designed to cause Petitioners substantial emotional distress or that these actions would have caused substantial harm or distress to a reasonable person in Petitioners position. The allegations that Mr. Wilson's conduct was part of a course of conduct directed at Mr. Suringa is unsupported by the evidence but rather indicates an attempt to support a woman involved in a contentious family law case that is ongoing.

- 2. The court is unable to find by a preponderance of evidence that Respondent caused physical harm, bodily injury, assault or the infliction of fear of imminent physical harm, bodily injury or assault to the minor child Petitioner or Mr. Suringa. It should be noted that this court only included this issue in the temporary order to provide temporary protection to the child as the court did not have confirmation of this issue being addressed in the Superior Court matter. Satisfied today that this and many other issues involving the best interests of the children are being fully addressed in the Superior Court matter this court does not feel it appropriate to address allegations of sexual assault of a child through an anti-harassment order and will not do so. That said the court is finding there is not a preponderance of evidence to support any injury to the child by Respondent.
- The court also finds that the medical reports provided do not support any finding of sexual abuse of the child and the court is concerned that the child's wellbeing as well as Respondent's are harmed by Petitioner's actions in this matter.
- 4. Respondent engaged in stalking of Petitioner(s) as defined in RCW 9A.46.110.

#### **ORDER**

### Having entered the findings above, IT IS THEREFORE ORDERED:

The request for a Protection Order is DENIED. Any Temporary Orders issued in this matter are hereby terminated and the case is DISMISSED WITH PREJUDICE.

NOTE: Only the Civil Protection Order in this case is DISMISSED. This dismissal does not affect any other Protection, Restraining or No Contact Orders that may protect either party.
