2. I declare: Child Support was set in default prior to maintenance being set.

Such income orders as have been set forth are not the intention of the law.

My income currently is being used almost entirely to cover maintenance obligations set forth by the court due to faulty figures being presented.

Incorrect income and figures were submitted to calculate child support and

prior to maintenance. Maintenance was not being calculated into the child support figures. It has now been six months that I have been unable to obtain my own apartment, home. It has been over 3 months since

I could afford legal counsel. I went to a title 26 certified public accountant to review and assist me in calculations based on the RCW law. I have attached the worksheets which are correct to the best of my knowledge and based on my financial declarations and the expenses attached which were submitted to the court on 2/6/2018. Thank you for helping to rectify this matter.

I am paying for multiple adults to live in that house rent free. It's a 5

bedroom 3.5 bath house with a 3 car garage causing the utilities to be

extremely expensive. The petitioner claims she can not get a job but her mother was working within 10 days of arriving in america with 0 english.

She is benefiting from these current calculations in this case as I am unable to afford a legal defense at this time. I am 16,000 dollars into defending myself from vexacious litigation without any burden of proof from the petitioner that anything submitted is true. This situation has us unable to afford the GAL and mediation that this case needs to desperately. There is no retainer money available at this time. I basically qualify for food stamps at this time under RCW 26.19.071.

Currently having to pay for gasoline to get to work and to eat on credit cards. I am living on the generosity of a strong family support system. The disparate income situation has me unable to keep up with my financial obligations. I am asking the court to accept

my child support worksheets in efforts to assist the petitioner in understanding some of the changes that we face as we are nearing the last 90 days of this marriage so we can settle and mediate much easier.

I am also asking the court to consider the RCW's in regards to what is

a credit from September 27, 2017 until this petition is set in regards to my child

support on the child support order.
