from the GAL list maintained by the court with each party striking one name. The remaining name was Heather Lund. Ms. Lund informed the parties she would accept the case and enter an order appointing GAL upon receipt of a \$2,500.00 retainer fee.

- 6. An Order re: Allocation of Guardian Ad Litem Fees was entered February 16, 2018 ordering Respondent to pay 81% and Petitioner to pay 19% of the retainer.
- 7. Respondent has refused to pay the ordered percentage, maintaining that the Temporary Child Support Order should be modified to order that Petitioner should pay 71% of the GAL fees. Consequently no GAL order has been prepared nor is an order imminent.
