- 1. I am Sirinya Surina mother. I live with Sirinya and my grandchildren David and Andrew Surina. I help with the exchange of the boys when they visit with their father, Aaron Surina
- 2. On Wednesday, May 23, 2018 Aaron took my telephone from our residence without my permission. I have used this telephone since I arrived in Washington state to live with Aaron and my daughter. Aaron and Sirinya sponsored me to come to the United States from Thailand. I have private data, photos, email and messages, account access to Social applications and programs, access to my Social applications "Friends" and their private messages and data on the telephone.
- 3. Getting David to take the telephone to him. When Aaron brought the boys back at 7:00 p.m. I went to the curbside and brought Andrew into the house, as usual. David stayed

outside playing on the front lawn. I called for him to come in, but Aaron stayed in the car and called something to David. I didn't know what he said to David but then David, my five-year old grandson ran past me into the house and grabbed my phone from the kitchen counter, where I had it charging. David then ran back out the door past me. I tried to stop him, but I couldn't catch him. I have very bad knees and can hardly walk, and I can't run so I couldn't catch David in time.

- 4. He ran down the driveway to where Aaron was waiting in the car. I called to David to bring my phone back, but he didn't. Aaron was calling to David to hurry, hurry with the phone and David gave it to him then came back to the house and Aaron drove away
- 5. <u>Use of Telephone</u>. This is my phone. Aaron gave it to me when I arrived in the US and it has never been anyone else's phone since that time. I use it every day. Now it is gone with all my personal correspondence and information. Aaron set the phone up for me with passwords and user names, so he knows how to get into my applications.
- 6. When Sirinya, my daughter, got home from school I told her what happened. She emailed Aaron to bring it back now or she would call the police. Aaron didn't answer so Sirinya called the police and reported the theft.
- 7. The Crimecheck report is #201810068841.
- 8. Aaron said that the boys use that phone when they go with him for visitation. That is not correct, the phone is mine and has been with me, not them. That phone has never been taken to Idaho or anywhere else outside of our home except by me. That is not Aaron's phone. He gave it to me, but I can only use it on Wi-Fi for internet calling I have no cellular sim phone number on that phone.
