REPLY DECLARATION OF: SIRINYA SURINA RE: RESPONDENT'S RESPONSE TO PETITIONER'S MOTION FOR CONTEMPT – June 8, 2018

Sirinya Surina Declares:

- 1. I am the Petitioner and moving party for the motion for contempt;
- 2. <u>Immigration Sponsor</u>; <u>Page 1</u>, <u>Lines 19-23</u>: Several times Aaron stood in court and said he "sponsored" both me and my mother, Benjamas. He used "sponsorship" to justify taking and keeping my personal and official documents from our home safe. He also used "sponsorship" when he accused Carl Wilson, in his District Court anti-harassment suit. He accused Carl Wilson of attempting to falsely fill out DSHS forms for Benjamas that could cause her to lose her visa that he had spent so much time and money helping her to obtain, as her sponsor.
- 3. Receiving Mail at my Residence; Page 2, Lines 1-9: I check the street mail box a few times each week. No mail has been delivered to that mail box for several months. I still check it because Aaron sometimes leaves the kids clothes or toys there when they forget

to bring them home after visitations with Aaron. As far as I know, all mail addressed to Aaron goes to his P.O. Box, even the junk mail to "occupant" or "resident." This includes the utility bills and any other bills that do not specifically have my name on it, or sometimes even if it is addressed to me. Aaron gives me the bundles of junk mail and, to the best of my knowledge, any other mail that may be addressed to me which is forwarded to him at his P.O. Box.

- 4. Forwarded Mail. Most mail addressed to me goes to my personal P.O. Box. The Post Office wouldn't let me forward from 1616 S. Rocky Ridge Drive to my own P.O. Box because the Street address is in Aaron's name, only. I had to inform all of my contacts of my own P.O. Box number to get my mail delivered to me.
- 5. I have never received the Water Bill, Electric Bill, Waste Management Bill, Hyundai Bill, or any of the other house maintenance bills. Aaron had all this mail forwarded to him shortly after he was removed from the residence.
- 6. I received some medical and insurance information that I immediately give to Aaron at child exchanges. I text photos of what I am giving him before the exchange.
- 7. Failure to pay court ordered community bills. Had I not been notified by my attorney that the car payments had not been made, it is possible my car would have been towed away for repossession. I called the Credit Union, and because my name is on this loan, they told me that the payments were well in arrears. I informed Aaron he needed to get that payment made before the Credit Union came to take my car. I had no knowledge that the water bill was 3 months in arrears nor that the phone bill was so late that both of these utilities were disconnected or suspended. I had to pay the water bill plus a reconnection fee or my house would have been without water more than the few hours that it was.
- 8. Aaron's time off work. Aaron wouldn't have had to take 40 days away from work had he not wanted to "Do it himself." To "Stand in front of the Judge" and get full custody of the children as he boasted on Social Media, and that he also told our children, he was going to do. He earns \$2500 a week but gave that up to represent himself. He has filed numerous, unnecessary, and vexatious motions that have cost me some tens of thousands of dollars in legal fees.
- 9. <u>Unemployment.</u> I am not working because I'm going to school evenings and nights to

prepare myself for the job market. I was successful in Thailand, before I joined up with Aaron. But now I'm in this country and it's a lot harder to proceed, but I'm determined to do so. I have no intentions of moving back to Thailand. I have no holdings, no investments and no profits from anything in Thailand.

- 10. <u>Cell Phone Removal from Residence</u>. Aaron's story about David bringing his work phone home is a fantasy. David never brought a phone home. Aaron has the phone he claims David "accidently" brought home. He sent David into the house to "get Grandma's phone" and that is what David did. The phone Aaron gave my mother, Benjamas, when she arrived in the U.S. last May 2017. It has never been David's phone and the only game David played on it is one that I downloaded a week before Aaron took it. Aaron's work phone has not been in the house since Aaron left the house last August, except he may have had it when he came to pick up his personal possessions. Aaron wanted the information on my mother's phone, clear and simple. Evidently, he has it set up to take photos whenever it is touched or picked up.
- 11. Aaron's false changing false narrative regarding telephone: Aaron dropped the children off at 7PM. He waited until he coaxed David, who was playing on the front lawn, to run into the house and grab my mom's phone and bring it out to him. By the time I returned from school, Aaron was gone but I emailed him, about 20 minutes later, at 7:35 PM to return the phone. Aaron said he didn't realize the phone was the wrong one until he got home. He was less than 30 minutes away, not even half-way to Hayden, Idaho at the time I emailed him. Exhibit A. I emailed him again, two days later, May 25, and he responded that he didn't have my mom's phone. But, on Thursday, May 24 at 10:35PM, he sent a text to his friend that he got his phone back (it was his phone until he gave it to my mom a year ago) and that my mom's phone "accidentally takes pictures, hahahahaha. Owned. I'm done. BWAHAHAHA. It's a wrap for the whole crew." See Exhibit B. true and correct copies of Aaron Text Thread.
- 12. He was mining the private intellectual data and photos from my mom's phone. It was never about a "work phone." When he had retrieved all that he wanted, Aaron took the phone to a T-Mobile store and then notified me I could pick it up there, which is what I did.
