

DECLARATION OF: SIRINYA SURINA RE: SANCTIONS PURSUANT TO

Sirinya Surina Declares:

- 1. I am the Petitioner and mother of David and Andrew Surina.
- 2. Aaron began planning and organizing to file for divorce during the summer of 2017. He declared that he was planning in his early response declaration as follows:
 - ".... I asked my mother to come to help me manage the legal process of filing for divorce and custody. She arrived to help me manage the legal process, to support me emotionally and to serve as a witness of the situation in my home. Since my mother's arrival at the beginning of August, in between making appointments with legal counsel . . .
- 3. When Aaron was removed from our residence on or about August 14, 2017 he had already started to take possession of and remove various legal documents from our residence. I have now discovered he had also started to have all our mail, including junk mail, forwarded to his P.O. Box. I have attached a letter from the Postal Service

announcing mail being forwarded to P.O. Box as Exhibit A. This letter was provided to me by Aaron in answers to his interrogatories.

- 4. When I got tired of mail sent in my name being forwarded to Aaron's P.O. Box, I got my own P.O. Box. However, all the house related mail including but not limited to utilities, tax statements and mortgage statements continued to be forwarded to Aaron's P.O. Box. When I tried to contact the mortgage lender, Avista Utilities and the lender for my auto, I was rebuffed as not being the person whose name was on the various statements. I was able to obtain copies of the water bill attached to my declaration only because it included "or resident" on the statement. I had previously not received the water bill or any other house related billing statements. In fact, I have received notice from the Post Office that the group mail box in the neighborhood is vacant for the second time. See Exhibit B
- 5. Aaron once again attempts to mislead the court when he says he never received the water bill. He has also submitted misleading statements to the District Court. Please see Exhibit C, which are copies of Aaron's submission to the District Court alleging that he had not received a certified copy of Carl Wilson's court pleadings. In fact, the reason he didn't "receive" the copies was that he declined acceptance of the certified copies at the Post Office until after the court hearing. This is another example of him trying to be tricky.
- 6. I have been recently contacted by a representative from our mortgage company asking to Aaron to contact them. I am concerned he is not paying the mortgage as ordered. Exhibit D.
- 7. It costs me additional attorney fees to compel Aaron to follow the court's orders. I ask the court to sanction Aaron for his false statements regarding the water billing and pay attorney fees in the amount of \$1,000.00.

I declare under penalty of perjury under the laws of the state of Washington that the foregoing is true and correct.


