I Declare: My name is Christine Surina. I am Aaron's mother. I met Oh when I picked her and Aaron up at the airport from Thailand in November 2011. I lived in Reedsport with them for a time. Things seemed ok between the two of them until David was born. I was there when Oh gave birth to David. Oh did not bond with David, and refused to hold or care for him. I was often called over to help her. Aaron was actively involved when he got home from work, sometimes getting off early to help. I have visited frequently their home both in Bremerton and Spokane. The arguing is horrible. I have been angry with both of them at times for doing it in front of David, and now Andrew. After all these years, I do not think Oh ever loved Aaron. It breaks my heart to see how much hate she has for him over the years. She'd call him lazy and no good. I came up in August 2017, at Aaron's request because he was going to see about filing for a divorce. I have never seen Aaron violent with Oh. I have seen him argue with her, but she was typically the aggressor. I have seen Aaron devoted to his boys and go out of his way to take care of them. After Aaron was served the restraining order, I too had to leave the house. I have seen Oh pack up the house, visible at exchanges. David is excited to come see his dad at exchanges, and visibly upset when he has to return. Aaron is a good dad and very involved. This restraining order is baseless and I ask the court to deny it and grant Aaron significant time with his boys.
