Declaration of Kari Carson

I Declare: My name is Kari Carson. I am Aaron's oldest sister. A few years ago on Aaron's birthday, we planned a family trip to the tulip festival. While we were waiting for Aaron and Oh to take a ferry, I called him to touch base. He answered, but all I heard was him and Oh screaming at each other. When they finally arrived, Aaron had nail polish all over him and a welt on his cheekbone from where Oh threw the bottle at him. Oh did not say a word or interact with me the whole time we were at the tulip gardens. Later I spoke with her and she mentioned that Aaron treated her badly.

A year or so later, I visited when Allie was in town as well. David started choking on food and immediately Aaron and Oh began arguing and yelling at each other. There was no concern that Allie, Zoe and I were right there. David cried and ran off. The fighting between Oh and Aaron made the whole situation worse and uncomfortable for everyone. I didn't want my own child to be influenced by such displays. Honestly, I have avoided being around this potentially volatile situation ever since. It's not healthy. I don't believe that Oh's intentions were ever genuine. I have my own opinion of her. I am disappointed in my brother for being dragged down to Oh's level.

Regardless of their difficulties, Aaron is a great and involved dad and person- fun, generous, and hard worker. He is not violent, and never has been. I am more concerned about Oh's domestic violence.
