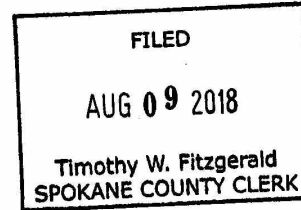

Sirinya Surina Declares:

1. Mr. Surina attempts to mislead the court when he suggests that I somehow voluntarily quit claimed by interest in our family residence.
2. Three times, in the "Verbatim Report of Proceedings Oral Argument of Mr. Aaron Surina" (District Court No. 18720043 Surina vs Wilson, District Court), Aaron mentions the reason he had Sirinya sign the Quit Claim deed was to obtain a better interest rate on his loan (Pages 21 and 25).
3. Aaron told me that he and I owned our residence. I found out differently after we separated and Aaron started telling me it was his house and that I was going to get kicked out with nothing. I checked out how our property was listed and discovered that he had been lying to me about my interest in our family residence.
4. On one hand Aaron has filed several motions and declarations with the court that he couldn't afford to continue to pay child support, community expenses and pay his share of

1 the court ordered GAL fees. On the other hand, he represents that he has the resources
2 to cash me out of my share of the family assets that are to be divided by the court and pay
3 the attorney fees he has caused me to incur.

4 5. He complains about not having enough money, but refused to file a joint tax return where
5 the court order a 50/50 split of the refund, which would pay him over \$2,000. He agrees
6 and then refuses to sell our residence, which would eliminate a large chunk of our
7 community obligations.

8 6. I am asking the court to allow me to market our family residence because neither Aaron or
9 I can maintain the monthly mortgage and pay the other person his or her community share
10 of the equity of the residence.

11 7. I have incurred \$1,200 in attorney fees in bringing this motion before the court. I am
12 asking the court to require Mr. Surina to pay these fees and enter a judgment in my favor
13 for these fees.

14 I declare under penalty of perjury under the laws of the state of Washington that the foregoing is
15 true and correct.
