Aaron has tried to come to multiple gatherings and include her, but she refuses. Every time I have come to visit, even briefly, she was yelling at him the entire time and refused to have a conversation with me or even acknowledge our existence. Aaron is a wonderful father. He is a devoted and dedicated husband even though she has shown him absolutely no love in return.

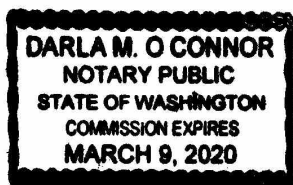

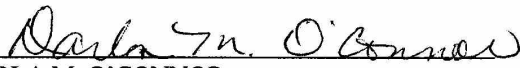
