RESPONSE DECLARATION OF: SIRINYA SURINA RE: RESPONDENT'S MOTION FOR TRIAL CONTINUANCE AND GAL

## Sirinya Surina Declares:

- 1. <u>Litigation Costs</u>: I have borrowed thousands of dollars (\$55,250.00) for attorney fees mostly in response to Respondent's baseless motions, which included defending against an attempt to have a Thailand divorce and custody order enforced by the Washington State Court. Additionally, I currently owe my attorney approximately \$22,000.00 in fees much of it for trial preparation. Respondent has communicated to me that unless I agree to what he wants, he intends to keep litigating this matter even if it costs "millions."
- 2. <u>Waiver of "private GAL</u>. Respondent has previously moved the court for an order waiving the requirement for a private GAL.
- 3. <u>Mediation</u>. We have attempted to mediate our parenting plan unsuccessfully on 3 different occasions with mediator Jim Hatch. Shortly after our last mediation, I had my attorney once again submit 3 names of qualified mediators. (Suzanne K. Bartleson, Nina Roecks and Patrick Donahue). Respondent did not respond.

- 4. Records Related to Children. We have a lot of third-party information about the best interest of our children. We have dozens of police records and CPS records submitted as exhibits for trial that could be entered by agreement. We have a child parenting assessment for Respondent completed by Linda Wirtz, M.A. We have dozens of hearing transcripts where Respondent has argued on behalf of our children's best interest. Although I have not seen any records from Respondent, Ms. Wirtz directed Respondent to services from Circle of Security. The court may have records from Circle of Security to review.
- 5. GAL. Court Commissioner Swennumson ordered the appointment of a Guardian ad Litem on February 6, 2018. We have been attempting to get a GAL since that time. The last time we continued our trial date it was to get a GAL immediately and allow her plenty of time to complete his or her report before the June 10, 2019 trial date. Respondent claimed he could not come up with the required retainer and we had to get our house sold to have money to hire a GAL. He then proceeded to obstruct several buyers for our house and we attempted mediation. We are way beyond the time to appoint a GAL and I asked the court to not continue this case. We need closure.
