1. Relief Requested

My name is: Aaron Surina [Father of DMS & AAS]. I ask the court to approve the following orders:

Extend Trial until the G.A.L. investigation has completed.

Enforce the court's order for the G.A.L. which the petitioner continues to evade.

2. Statement of Issues

I ask the court to decide the following issues (*specify*):

1.

My children have not had any access to the G.A.L. services the court ordered for their protection after credible and disturbing reports of abuse and neglect surfaced.

3. Statement of Facts/Grounds

These facts support my request (*list supporting facts*):

1)

The court ordered a G.A.L. and I have been in absolute agreement. I have never agreed to dismiss or stipulate otherwise. I feel the court had good standing when ordering the G.A.L. as a necessary service in this situation.

2)

The petitioner has artfully evaded a G.A.L. or exposure to professional observation including the court's ordered counselor. It was claimed by the Petitioner on Aug 2, 2019 during pre-trial conference that these matters have been litigated previously. **This is false.**

We can not litigate away the need for a Guardian Ad Litem. It would not be in the best interest's of the children.

3) I have filed an amended final parenting plan in case the court would like to review it or alter it in regards to 191 issues and the Petitioner avoiding the court's

order. We also have a full and final divorce decree and final custody orders issued by the Kingdom of Thailand. (Our children are also Thai nationals)
