Child Support Order

1. Money Judgment Summary

No money judgment is ordered.

Findings and Orders

2. The court orders child support as part of this family law case. This is a final order.

3. The *Child Support Schedule Worksheets* filed separately are approved by the court and made part of this Order.

4. Parents' contact and employment information

Each parent must fill out and file with the court a *Confidential Information* form (FL All Family 001) including personal identifying information, mailing address, home address, and employer contact information.

Important! If you move or get a new job any time while support is still owed, you must:

- Notify the Support Registry, and
- Fill out and file an updated *Confidential Information* form with the court.

Warning! Any notice of a child support action delivered to the last address you provided on the *Confidential Information* form will be considered adequate notice, if the party trying to serve you has shown diligent efforts to locate you.

6. Imputed Income

To calculate child support, the court may **impute** income to a parent:

- whose income is unknown, or
- who the Court finds is unemployed or under-employed by choice.

Imputed income is not actual income. It is an assigned amount the court finds a parent could or should be earning. (RCW 26.19.071(6))

1 **7. Limits affecting the monthly child support amount**

2 Does not apply. The monthly amount was not affected by the upper or lower limits in RCW
3 26.19.065.

4 **8. Standard Calculation**

5 **All children living together** - All of the children are living with Sirinya Surina most of the time.
6 The other parent must pay child support. The standard calculation from the *Child Support*
7 *Schedule Worksheets* line 17 for the parent paying support is ~~\$4,466.68~~. **1550.78** mp

8 **9. Deviation from standard calculation**

9 Should the monthly child support amount be different from the standard calculation?:

10 **Yes** - The monthly child support amount ordered in section 10 is **different** from the standard
11 calculation listed in section 8 because:

14 Spend significant time during the summer months with the parent who owes support.
15 The non-standard amount still gives the other parent's household enough money for the
16 children's basic needs. The children do not get public assistance (TANF).

17 **The facts that support the reasons checked above are:**

18 Detailed in the *Worksheets*, Part VIII, lines 20-26

19 As follows: The children spend an equal amount of time with each parent during the
20 months of June, July and August. when he shall pay ~~\$733.34~~ for both children.

21 **10. Monthly child support amount (transfer payment)** **\$775.39** mp

22 After considering the standard calculation and whether or not to apply a deviation, the court
23 orders the following monthly child support amount (transfer payment).

24 **All children living together** - Aaron Surina must pay child support to Sirinya Surina each
25 month, except for June, July and August as follows for the children listed below:

- 1 *me* • Aaron Surina must pay ~~\$733.34~~ ^{\$775.39} in child support to Sirinya Surina during the summer
2 months of June, July and August.

3 **11. Starting date and payment schedule**

4 *me* The monthly child support amount must be paid starting ~~December 1, 2019~~ ^{January 1st, 2020} on the following
5 payment schedule:

6 In two payments each month: 1/2 by the 5TH and 1/2 by the 20TH day of the month.

7 **12. Step Increase (for modifications or adjustments only)**

8 Does not apply.

9 **13. Periodic Adjustment**

0 Child support may be changed according to state law. The Court is not ordering a specific
1 periodic adjustment schedule below.

2 **14. Payment Method**

3 Send payment to the:

4 **Washington State Support Registry.** The Division of Child Support (DCS) will forward the
5 payments to the person owed support and keep records of all payments.

8 **Important!** If you are ordered to send your support payments to the Washington State Support
9 Registry, and you pay some other person or organization, you will **not** get credit for your payment.

10 **DCS Enforcement:** DCS will **enforce** this order because: One of the parties has
11 already asked DCS for services.

12 **15. Enforcement through income withholding (garnishment)**

13 DCS or the person owed support can collect the support owed from the wages, earnings,
14 assets or benefits of the parent who owes support, and can enforce liens against real or
15 personal property as allowed by any state's child support laws without notice to the parent
16 who owes the support.

17 There is no good reason to delay income withholding.

18 **16. End date for support**

19 Support must be paid for each child until the child turns 18 or is no longer enrolled in high
20 school, whichever happens last, unless the court makes a different order in section 17.

1 **17. Post-secondary educational support (for college or vocational school)**

2 **Reserved** - A parent or non-parent custodian may ask the court for post-secondary
3 educational support at a later date without showing a substantial change of circumstances
4 by filing a *Petition to Modify Child Support Order* (form FL Modify 501) The *Petition* must be
filed *before* child support ends as listed in section 16.

5 **18. Claiming children as dependents on tax forms**

6 The parties have the right to claim the children as their dependents on their tax forms as
follows:

7 Every year - Aaron M. Surina has the right to claim David Michael Surina and Andrew
8 Alex Surina so long as Sirinya Surina does not benefit through the tax code to claim one
9 of the children, either through her employment or qualifying for an Earned Income Credit
as currently defined or by future amendments.

For tax years when a non -custodial parent has the right to claim the children, the
parents must cooperate to fill out and submit IRS Form 8332 in a timely manner.

11 **Warning!** Under federal law, the parent who claims a child as a dependent may owe a tax penalty if the
12 child is not covered by health insurance.

13 **19. Health Insurance**

14 **Important!** Read the Health Insurance Warnings at the end of this order.

15 The court is not ordering how health insurance must be provided for the children because
16 the court does not have enough information to determine the availability of accessible
17 health insurance for the children (insurance that could be use for the children's primary
care). The Division of Child Support (DCS) or either parent can enforce the duty to provide
or pay for health insurance

18 **20. Health insurance if circumstances change or court has not ordered**

19 If the parties' circumstances change, or if the court is not ordering how health insurance
20 must be provided for the children in section 19:

- 21 • A parent, non-parent custodian, or DCS can enforce medical support.
- 22 • If a parent does not provide proof of accessible private insurance (insurance that
23 can be used for the children's primary care), that parent may have to:
 - 24 • Get (or keep) insurance through his/her work or union, unless the insurance
costs more than 25% of his/her basic support obligation (line 19 of the
Worksheets),

- Pay his/her share of the other parent's monthly premium up to 25% of his/her basic support obligation (line 19 of the *Worksheets*), or
- Pay his/her share of the monthly cost of any public health care coverage, such as Healthy Kids, BHP, or Medicaid, for which there is an assignment.

21. Children's expenses not included in the monthly child support amount

Uninsured medical expenses - Each parent is responsible for a share of uninsured medical expenses as ordered below. Uninsured medical expenses include premiums, co-pays, deductibles, and other health care costs not covered by insurance. A parent can ask DCS to collect those expenses, or a parent or non-parent custodian can ask the court for a judgment.

Warnings!

If you don't follow this child support order...

- DOL or other licensing agencies may deny, suspend, or refuse to renew your licenses, including your driver's license and business or professional licenses, and
- Dept. of Fish and Wildlife may suspend or refuse to issue your fishing and hunting licenses and you may not be able to get permits. (RCW 74.20A.320)

If you receive child support...

You may have to:

- Document how that support and any cash received for the children's health care was spent.
- Repay the other parent for any day care or special expenses included in the support if you didn't actually have those expenses. (RCW 26.19.080)

Health Insurance Warnings!

Both parents must keep the Support Registry informed whether or not they have access to health insurance for the children at a reasonable cost, and provide the policy information for any such insurance.

If you are ordered to provide children's health insurance...

You have **20 days** from the date of this order to send:

- proof that the children are covered by insurance, or
- proof that insurance is not available as ordered.

Send your proof to the other parent or to the Support Registry (if your payments go there).

If you do **not** provide proof of insurance:

- The other parent or the support agency may contact your employer or union, without notifying you, to ask for direct enforcement of this order (*RCW 26.18.170*), and
- The other parent may:
 - Ask the Division of Child Support (DCS) for help,
 - Ask the court for a contempt order, or
 - File a Petition in court.

Don't cancel your children's health insurance without the court's approval, unless your job ends and you can no

longer get or continue coverage as ordered in section **19** through your job or union. If your insurance coverage for the children ends, you must notify the other parent and the Support Registry.

If an insurer sends you payment for a medical provider's service:

- you must send it to the medical provider if the provider has not been paid; or
- you must send the payment to whoever paid the provider if someone else paid the provider; or
- you may keep the payment if you paid the provider.

If the children have public health care coverage, the state can make you pay for the cost of the monthly premium.

Always inform the Support Registry and other parent if your access to health insurance changes or ends.
