• (SiDeNote: Thailand has outlawed this type of abuse of civil process as it's very common and something they are very familiar with apparently. Thai criminal code 326 discusses the epidemic of thai people attacking each other and their addressing this issue. Thailand outlawed this type of vexacious attacks on other nationals without warrant or justification.

## 6. It's fraud.

My children are starting to show serious signs of trauma from this long and chaotic situation where false notions and narratives have ruled over the lives of my children and I and forced us into a hell that nobody and certainly no children should have to be forced through.

- How long will I have to continue to be abused by this whole proceeding? Any rational person would find this case and the orders to be totally outrageous.
- Having to take off work while dealing with a global pandemic, working for the life and safety of our community, the communications at the hospital and all this stuff distracting me.
- ➤ I requested when I signed the QDRO on 12/20/2019 that the QDRO be turned in as quickly as possible hopefully before the end of 2019. It's mid March of 2020
- I am asking the court to consider the stock market crashing and the losses taken with regards to the dollar amount ordered in December. That is no longer a fair order

On or around June 6 2019, a secret hearing took place as I don't remember any hearing on 6/6/2019 where a ficticious judgement of 19,000 dollars was awarded without any evidenciary hearing.

I would like injunctive relief on this QDRO being submitted because there are two unknown judgements for the largest amounts in the case which were not something I ever witnessed in a hearing ordered against me to be paid to Sirinya.

I think I would have noticed a 19,000 dollar judgement prior to trial which appears to be on June 6, 2019.

I did ask Mr. Glanzer to verify the judgements and I asked the court to verify what they are but have yet to get any actual factual findings of how those entered the case against me.

I have satisfied those judgements to Sirinya as Judge Price dispersed the funds not knowing this type of fraud was taking place prior to our arrival at our 3rd judge (4th counting Swennumson).

One for 15,000.00 that was denied by Judge hazel when Mr. Glanzer tried to get the judge to order me to participate in an insurance scam and obtain money for the roof.

I am asking for help to clarify the judgements.

> I believe that the largest judgements were never awarded and were slipped into the case after Rich Kuck withdrew from the case.

I am asking for relief from this ongoing assault.

➤ I am asking for relief from threats of more litigation by Mr. Landrus and Ms. Polarj.

- > I am asking the court to remove the gag order which denies my children the right to talk with their father freely.
- Ms. Polarj insisted on not being able to talk to her own children while they are with me. I certainly do not feel the same way when they are not with me.
- I am very concerned about this litigation continuing, about my children in the care and custody of their mother who has shown the court time and time again of her malevolence and disregard for their condition entirely. Thank you for your time.
