I. BASIS

II. FINDINGS

- 2.1 The court has considered the *Motion for Contempt;* A hearing was held on Friday, May 17, 2019 and it makes findings as follows:
- 2.2 The <u>August 10, 2018 Order</u> on Motion to Immediately Place Family Residence up for Sale. . . Etc. found an economic need had been established and therefore a sale was necessary. (page 1; paragraph 2.4). The parties were ordered to cooperate in immediately listing and showing the home in a manner that would effectuate a sale of the residence as soon as possible after an offer was accepted. It further ordered that "No offer within current market value could be unreasonably withheld." (pg 2; line 15). The current market value offer to purchase the property includes a contingency to replace the roof. Respondent, Aaron Surina has failed to cooperate with the current offer to purchase the property when he unreasonably refuses to authorize insurance coverage on the contingency.
- 2.3 The <u>January 3, 2019 Order on Contempt</u> ordered "Respondent, through his attorney, to immediately provide Petitioner through her attorney all documentation regarding the mortgage lender including but not limited to...." All documentation regarding the mortgage lender necessarily includes its documentation on the insurance company insuring its interest in the subject property. Respondent refused to provide this information after repeated attempts to obtain it, which forced Petitioner Sirinya Surina, through her attorney to contact the mortgage holder to obtain the information to open a claim against the residential property.
- 2.4 The March 27, 2019 Order on Motion For: Conveyance of Real Estate clarified the court's January 3, 2019 order. It ordered respondent, Sirinya Surina to execute all documents named above to complete the sale of the family residence as ordered by the court August 10, 2018 with . . . buyers, if any, in the future. (page 3; line 16) Respondent's refusal to facilitate the current Purchase and Sale Agreement contingency to replace the roof and repair the fascia through an insurance claim prevents Petitioner from efficiently executing the Purchase and Sale Agreement contingency and forces the price of the sale to be reduce by \$15,000.00 or more.
- 2.5 <u>Contempt.</u> The August 10, 2018, January 3, 2019 and March 27, 2017 orders were not obeyed.
