TO THE HONORABLE JUDGE OF THE DISTRICT COURT OF THE UNITED STATES FOR THE EASTERN DISTRICT OF WASHINGTON:

The Defendant AARON SURINA (ASURINA"), by way of removal, pursuant to 28 U.S.C. "1331, "1441(a) and (b), and "1446(a), (b) and (d), would respectfully show unto this Court:

- 1. This action was commenced by the filing of a Summons and Complaint on September 24, 2020. The Summons and Complaint were served on the County Clerk on September 25, 2020. The action is now pending in the Spokane County Superior Court, which is located within the Eastern Division of this Court by reason of 28 U.S.C. *121(2). The Complaint alleges claims pursuant to 42 U.S.C. *1983 and state law.
- 2. Thirty days have not elapsed since the receipt of the Complaint by the Defendant upon whom it has been served and one year has not elapsed since the commencement of this action.
 The County has not yet answered or pled responsively to the Complaint.

- 3. Pursuant to 28 U.S.C. *1441(a), the Defendant may remove to the District Court of the United States, for the district and division embracing the place where such action is pending, any civil action brought in a state court of which the district courts of the United States have original jurisdiction. Pursuant to 28 U.S.C. *1441(b), any civil action of which the district courts have original jurisdiction founded on a claim or right arising under the Constitution or laws of the United States shall be removable without regard to the citizenship or residence of the parties.
- 4. By virtue of 28 U.S.C. **1331 and 1343(a), the United States District Court has original jurisdiction of any civil action for a claim under 42 U.S.C. *1983. Section 1983 does not expressly prohibit removal and the existence of concurrent jurisdiction in the state court over claims under 42 U.S.C. *1983 is insufficient, standing alone, to defeat the right of removal granted the Defendant under 28 U.S.C. *1441.
- 5. By virtue of the foregoing, the Defendant Surina hereby removes this action to the United States District Court for the Eastern District of Washington.
- 6. This Court has supplemental jurisdiction over the Plaintiffs state law claims which derive from a common nucleus of operative fact with the Federal law claims. <u>United Mine Workers v. Gibbs</u>, 383 U.S. 715, 86 S.Ct. 1130, 16 L.E.2d 218 (1966).
- 7. The Defendant Surina files herewith in this Court a copy of all process, pleadings and orders served by or upon them in this action, as a part of the Notice of Removal, which consists of the Summons and Complaint dated September 24, 2020.
- 8. The Clerk of Court for Spokane County, Washington, from which this action is removed, and Plaintiff and/or their counsel shall promptly be given written Notice that the Notice of Removal has been filed and shall be provided a copy of the Notice of Removal.
