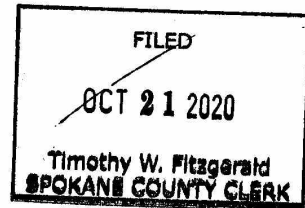

All of our out of pocket medical expenses were refused in "our family wizard", which Petitioner has a court ordered obligation to pay. The petitioner's continuous refusal to work or support her children when she could be contributing towards the children in the community makes it difficult for the children and parent involved. The children also complain of food rationing, limiting each child to 1 egg a day on some days.. There are padlocks on the cupboards and refrigerator to control access to any food by the children. Recently, the children were found on the south hill roaming barefoot by themselves with another child who is a close friend of DMS.

The petitioner testified on Sept 4, 2020 to allowing parties' children to roam the south hill w/o supervision

1. I am (age): 43 years old and I am the Respondent Father of the two minor children in this case:
2. I declare I have recently discovered evidence of financial incentives being received by the county commissioners to make certain child support enrollment and enforcement decisions in family law cases. Because of the significant amount of losses I have sustained and injury that has been left to me without remedy, I have brought my complaint to the United States District Court. I hope to get resolve from the federal court but in that process, I have the Spokane County Superior Court as a named defendant for obvious reasons relative to the injury and losses to my children and I. Due to that conflict of interest and the previous conflicts of interest that have had an effect on my case and remained undisclosed, I ask the court in it's current proceedings for a change of venue. It is not possible for this court to rule fairly at this point. Until the situation can be resolved and a divorce finalized, I ask that the venue change to an appropriate venue in a neighboring county.
