They made a lot of noise that they woke me up and bothered me. My grandson, Andrew was frightened and cried. Aaron's friend video-clipped Sirinya and me while we were in our pajamas. Aaron had his friend harassing me and Sirinya in our home. Aaron's friend also spent that night in our house. Sirinya told David to go to bed because she didn't want him to be hurt.
- 9. Aaron said he was going to send Sirinya and me back to Thailand but I didn't want to go back because I'm worried about my daughter.
- 10. Aaron has a very bad temper. He is very scary. Aaron drinks whiskey and beer and smokes marijuana almost every day.
