AFFADAVIT OF FACTS IN RE:
PETITIONER TRICKERY : WRIT
OF HABEUS CORPUS 11/9/2020

RESPONDENT AARON SURINA comes before this honorable court upon
Affadavit Bbeing of age and being competent of matters published in this affadavit,
DO SO speak the following:

INTRODUCTION

1. Aaron Surina was at court, Monday morning, 11/09/2020, with documents from Sacred Heart Children's Hospital, dated Sunday, 11/08/2020, with Doctor's Orders saying to not return the children to their mother and to go to court the next day (Monday, 11/09/2020) and request a Protection Order of the children from their mother – Sirinya Surina. *SEE EX A & B*
2. WA DCYF and court noted on 11/6 "Dad must bring children in to Doctor for evaluation of abuse and molestation while in the Petitioner's care. *SEE EX C*

FACTS SUPPORTING AARON SURINA

1. The court staff refused to allow Aaron Surina to file a Motion in Ex-Parte, refused to allow Aaron Surina to request or obtain the Protection Order that the hospital instructed to request. — **EXHIBITS A & B**
2. On Monday, 11/09/2020, morning, Sirinya Surina, was also at the court house – again – requesting a Writ from the court.
3. The court ignored and disregarded the Hospital, Doctor Orders, and issued a Writ of Habeas Corpus without involving Aaron Surina although he was right outside the court room and was Served the WRIT OF HABEUS CORPUS without due process or an opportunity to be heard.
4. ON 11/05/2020 – Aaron Surina attempted to exchange the children. Sirinya Surina refused communication and did not pick up the children. Aaron Surina also asked, "where can we meet?" Parenting Plan – Receiving Parent Picks Up
5. ON 11/09/20 – Aaron Surina was at the court house – with Hospital / Doctors Orders instructing to NOT return the children to Mom and to go to court and request an emergency custody/Protection Order.
6. Sirinya Surina has mislead the court in her filings regarding all of the above in her pleadings and requests to the court in November and December 2020.
7. Sirinya Surina has repeatedly pursued Writ's from the court to remove Aaron Surina, Dad from the children, since their child recently told of both physical and sexual harm to him and their younger son, done by Mom and others at Mom's house.

2 8. The child has told the police, his school, doctors, his Dad, his Dad's family, the
3 court and additional sources not listed in order to protect the innocent.

4 10. The Protection Order request is still an open request with the court. The hearing
5 was supposed to be held on November 19, 2020, but was not held by the court due to the
6 same court staff misleading Judge Dixon with regards to what was on the calendar for
11/19/2020..

7 13. Both parties were present for the hearing on 11/5/2020 and 11/19/2020. All of the
8 documents are on file. SEE EXHIBIT D.

9 CONCLUSION

10 Due to the overwhelming amount of lies, deception, fraud and court staff meddling with
11 these issues, I ask the court to come to a conclusion and accept my motions for cr 1,
12 stop Petitioner from further motions intended to further harass, intrude on custody,
13 prevent ability to work full time while defending baseless and unsupported attempts at
14 gaining full custody.

Given the information that David shared with me and David's physical exam findings and after consulting with a the Child Abuse Experts at Partners with Family and Children, I do not recommend David or his sibling return to mother's care until an investigation can occur into the allegations. I am discharging him into your (Father's) care. This recommendation is for David's safety. Please call your social worker, Rena Perez, tonight or tomorrow morning to see if they are able to help with this. I attempted to reach her but she was not available to discuss this recommendation. If that is not possible, please pursue an emergency protective order at family court tomorrow.

Clotrimazole cream twice a day for 7 days in groin area for yeast infection.

Albuterol 2-4 puffs every 4 hours as needed.
