RESPONDENT AARON SURINA comes before this honorable court upon
Affadavit being of age and being competent of matters published in this affadavit,
DO SO speak the following:

INTRODUCTION

- Allegations about the the 5th of November are important
- November 5, 2020 was a court date respondent obtained an OTSC
- This affadavit proves the truth about Petitioner's allegations on 11/5/2020
- Aaron Surina was not withholding the children ON 11/5, 11/6 OR ANY OTHER TIME.
- Sirinya Surina refused to respond to the message intentionally to obtain a writ of habeus corpus. The writ was denied on the 6th.
- The commissioner clarified on 11/6/2020 that it was Dad's weekend.
- Petitioner did not reply to respondents attempts to communicate an exchange on 11/5/2020. See attached Exhibit A & B.

FACTS SUPPORTING AARON SURINA

1. Sirinya Surina claimed in multiple pleadings with the court in November and December 2020 that Aaron Surina did not return the children on 11/05/2020.
2. Sirinya Surina is not telling the court that Aaron Surina communicated with Sirinya Surina through the OUR FAMILY WIZARD app regarding exchanging the children, multiple times on 11/05/2020. **(See Attached – Exhibit A & B)**
3. Sirinya Surina saw the messages – per the OUR FAMILY WIZARD feature that tells when the other party views the message, however, Sirinya Surina did not communicate to exchange the children. **(See Attached – Exhibit B)**
4. Aaron Surina waited for approximately 2 hours, at state line – Idaho/Washington – Cabella's parking lot – to exchange the children and for a response from Sirnya Surina.
5. Sirinya Surina did not respond to exchange the children.
6. Sirinya Surina went to court on 11/06/2020 and petitioned the court for a WRIT of habeus corpus on Aaron Surina for not returning the children on 11/05/2020.
7. Sirinya Surina did not communicate or respond to communication to exchange the children.
8. Sirinya Surina refused to get the children on 11/05/2020.
9. Sirinya Surina refused to get the children and followed that with going to court and requesting a Writ of Habeas Corpus with reason that Aaron Surina did not return the children.
10. Sirinya Surina's claims to the court are not only false but seemingly calculated and planned.

- 2 11. The court ordered that the children were with Dad for the weekend.
- 3 12. The court did not grant Sirinya Surina's request for a Writ on 11/06/2020 as Sirinya
- 4 has claimed in her pleadings for the hearing(s) on December 17, 2020.
- 5 14. On Friday, 11/06/2020, Commissioner Swemmunson confirmed that it was Dad's
- 6 weekend -11/05/2020 after school to Monday, 11/09/2020 morning.
- 7 15. On Friday, 11/06/2020, Commissioner Swemmunson noted that DCYF said that
- 8 Dad MUST bring the children to the doctor for an evaluation.

9 **CONCLUSION**

- 10 1. These events of Sirinya Surina repeatedly filing false claims to the court, requesting
- 11 Writs multiple times, requesting that Aaron Surina be jailed and lose his rights to
- 12 parent his children are factually baseless and threadbare.
- 13 2. Surinya Surina's pleadings and requests to the court November and December 2020
- 14 - happened in the midst of active major crime investigation of reports of child abuse
- 15 and child molestation - reported by child, DMS, teachers, and family .
- 16 3. DMS reported to police, to his teacher in multiple ways, to doctors, to family members
- 17 and to the court commissioner herself (Nicole Swennumson, who allowed DMS to
- 18 testify of the abuse on 11/10/2020.
- 19 4. DCYF and the Spokane Police Dept have received numerous reports of child abuse
- 20 and child molestation at Mom's house by Mom and others
5. These attempts to steal custody from Dad are fraud and should be met with cr11.
