

## **Motion for Contempt Hearing**

### To both parties:

If you want the court to consider your side, you must:

- File your original documents with the Superior Court Clerk; AND
- Give the Judge/Commissioner a copy of your papers (if required by your county's Local Court Rules); AND
- · Have a copy of your papers served on all other parties or their lawyers; AND
- Go to the hearing.
   The court may not allow you to testify at the motion hearing. Read your county's Local Court Rules, if any.

Bring proposed orders to the hearing.

#### To the person receiving this motion:

If you do not agree with the requests in this motion, file a statement (using form FL All Family 135, *Declaration*) explaining why the court should not approve those requests. You may file other written proof supporting your side

- **1. I declare:** I am the father of DMS and AAS, I arrived to pickup my two children at the court ordered time according to the parenting plan on December 17, 2020.
  - a. I had a lawful right to the physical custody of my children based on a residential schedule ordered by the court.
  - b. I was denied access to my children by 3 people on December 17, 2020 intentionally without regard for law.
  - c. Sirinya Polarj, Keith Landrus and Benjamas Srirattanakun were present and all partipated in this interference.
  - d. These 3 worked together and intended to deny me access to my children on December 17, 2020 at around 3pm.
  - e. My children and I were deprived of approx. 24 hours of Court ordered residential schedule with an extreme level of

harassment, intimidation and threats on 12/17/2020 which continued and has not ended.

Motion for Contempt Hearing 2

RCW 26.09.160, 9A.40.060 Mandatory Form FL All Family 165 p. 1 of 5

The other party, Sirinya Polarj, did not obey the orders checked below that were signed by the court 12/20/2019.

The parenting plan on Page 3 section 8, Page 8 section 12, Page 9, section 14 items (b), and Page 10 Lines 10, 11) outline the following:

- a. The Parenting Plan under the school schedule Dad picks children up on his Thursdays.(Page 3 s8)
- b. Mr. Surina transports as receiving parent, required to pickup on exchange days when they will reside with him. (Page 8 s12)
- C. The parenting plan also outlines there is to be no interference or intentional conflict.
   ((Page 9 section 14) items (b),(m))
- d. Refusing to allow the other parent access to their children is also illegal under RCW 9A.40.060.
- e. The current parenting plan drafted by the Petitioner on Pg10 Lines 10 and 11 includes a warning that a violator could face arrest for violating the parenting provisions in the order.
- f. Mr. Surina was denied any contact with his children, on his scheduled pickup, after the hearing on December 17, 2020. See attached order Exhibit A (The parenting plan)

## Parenting plan or residential schedule

Describe how the order was not obeyed including dates and times:

On Thursday, December 17, 2020, right after the hearing in front of Judge Dixon, the following violations occured at approx. 3pm.

- 1. Page 10, Lines 10 and 11 outline custodial interference.
- 2. Mr. Keith Landrus approached Mr. Surina and Mrs. Colby while they were sitting in their vehicle at the curb for pickup at 227 E. 22nd ave, Spokane, WA 99202
- 3. Mr. Landrus had confirmed that it was Mr. Surina's day and that Mr. Surina would not get his children and assisted Sirinya Polarj and her mother Benjamas Srirattanakun with concealing and retaining Mr. Surina's children intentionally, knowing the court's order and his scheduled residential time with his sons.
- 4. Page 9 section 14 items (b) and (m). Do not cause unnecessary conflict or delay the exchange against the other parent's will. The intentional chaos at the beginning of Mr. Surina's Christmas break which began during his weekend was shocking and an assault on Mr. Surina, Dad.

- 5. Mr. Landrus kept making the edicts "There is nothing you can do other than file a contempt or call the police and the police won't do anything about it and the court will take weeks and won't listen to you and court orders don't matter". "You're not getting your kids today".
- 6. AAS, Mr. Surina's 4 year old was in the window crying trying to get out of the house but was being held back by Benjamas Srirattanakun whom was the perpetrator in a DVPO protecting Mr. Surina's two children from her, less than a month prior.
- 7. Benjamas Srirattanakun is the 3rd member assisting with the custodial interference in the 1st degree and a relative outlined in section 1 of 9A.40.060 .
- 8. Benjamas Srirattanakun intentionally acted to prevent Mr. Surina from access to his youngest son, by physically restraining AAS from going with his father on his court ordered time which was visible through the front door which is a large window.
- Sirinya arrived and implicated that the custodial interference was planned and insisted that
   Mr. Surina would not be getting his children on December 17, 2020 regardless of the order.
- Sirinya went into the house and pulled AAS from near the door, AAS could no longer see
   Mr. Surina.
- 11. Sirinya and her mother Benjamas, both prevented AAS from coming out to go with Mr. Surina; AAS could see Mr. Surina at the curb, in front of the house.
- 12. Mr. Surina and his two sons were not able to have contact at any time on Dec 17, 2020.
- 13. Sirinya told both boys that they didn't go with Dad because Dad did not want to wait for them.
- 14. On December 18, 2020 Mr. Surina was asked by his son why he was not willing to wait for him to get to his mother's house the previous day on December 17, 2020. "Mom said you did not want to wait for me and just left" which both Mr. Surina and Mrs. Colby witnessed.

**Note:** See Declarations of Karmen Colby, Auntie to both children and witness to this encounter with Mr Surina & Sirinya Polarj, Keith Landrus and Benjamas Srirattanakun.

#### Other order:

Describe how the order was not obeyed including dates, times, and amounts, if any:

- a. Sirinya was speaking disparagingly about Mr. Surina in front of the boys.
- b. Sirinya delayed pickup far beyond the 5 minutes outlined in the court's order by concealing the children for over 24 hours to intimidate the children and Dad.
- c. Sirinya also enlisted Mr. Landrus who threatened Mr. Surina that they may keep them until the following Monday, advising Mr. Surina and his sister Mrs. Colby,. who witnessed the entire event that "they could interpret the parenting plan any way they want to"
- 3. Request I ask the court to:
  - Find the other party in contempt,
  - Order the other parties to go to court to show why the court should not approve the judgment and orders Mr. Surina requested,
  - Consider this motion under the statutes (RCW 9A.40) and the relief designated within that chapter which is included in the court ordered parenting plan (P10.L10,11),
  - ✓ ✓ order Petitioner to take the AAPI-2 adult adolescent parenting skill evaluation.
  - Approve the requests checked below
