I am Karmen Colby and I attest: I am 49 years old, I am a mother of 3 children, the sister of Mr. Surina AND Aunt of Mr. Surina's two sons DMS and AAS.

1. I am competent to testify of the events herein. I am of sound mind and knowledgeable of this case.
2. My attached letter; I sent by email on 12/22/2020 to Stella Bear with DCYF contains facts about 12/17, 12/18, and additional dates and details, including requesting help for Mr. Surina's children in this situation.
3. If I have not provided the proper words or form required to help these children, please advise me of any deficiencies to prevent further harm from happening. I ask the court to intervene on behalf of my two nephews.

Note to start. It is Christmas. Aaron wants no conflict and is avoiding it in every way possible.

I am giving you an update as it seems you are supposed to be told so I suppose you should be told now.

We are just trying to enjoy Christmas and make it happy and filled with love and joy.

Court 12/17 - Sirinya was requesting the court to jail Aaron, to have a restraining order and to give her custody. Court denied. Her claims to the court were either false or misleading.

Back Note - Sirinya had him saved a FAKE restraining order on 12/3 and then reported he kidnapped his kids when he picked them up late due to her FAKE restraining order. Law Enforcement involved.

Then she got a Writ of Habeas Corpus and Law enforcement Orders to break down doors, arrest Aaron and get the kids, when she had the kids.

The Judge vacated / quashed it.
It was all fraud and invalid.

I sent you the report on Monday, 12/07 that Mom told DMS, he would never see his dad again.

Thursday - 12/17/2020 - Sirinya (Mom) refused to exchange the children.

There are many details that go with that.

Her friend - Keith Landrus - came up to the car when we were waiting curbside to get the boys. He agreed that it is Aaron's pick-up but said Court Orders don't matter, you aren't getting the kids. Go ahead, call the police, the police won't do anything. Go ahead, go to court, it takes time and contempt doesn't have teeth. You aren't getting the kids today.

He even tried to negotiate, how about you give her an extra day, let them stay with her today and you can get them tomorrow.

He added, that they could argue that he doesn't get them until Monday.

* Thursday was Aaron's pick-up day.
He did not get the boys on Thursday.

Friday - Note - Parenting Plan is that Aaron picks up DMS from school and then picks up AAS - from Mom, until AAS is in school.

With Covid and online, at home school, Aaron has been picking up from Sirinya but now DMS is going to school for school.

Aaron picked up DMS from school on Friday.
School was done at 11:50am - confirmed with DMS teacher.
He was in camp after.
Aaron tried communicating with Sirinya repeatedly and she did not communicate.
Aaron picked DMS up @ 1:30pm having waited for Sirinya to communicate.
He let her know he picked up DMS.
Still no communication.
We waited essentially from 11:30am until 3:30pm to get the boys.
Aaron finally got AAS at 3:30pm with Sirinya screaming and going to the school, reporting that Aaron isn't allowed to go to DMS school and reporting him.

Note - Parenting Plan is that Aaron picks up DMS from school.
However, Sirinya makes her own rules. Aaron tries to avoid conflict at every turn and makes it as conflict free as possible.

Next - DMS said he has injuries and needs to go to the Hospital.
He has bruises from a hand grabbing his thigh. He said he got grabbed.
I didn't see it.

Aaron brought them to Sacred Heart. Sacred Heart did their exam.

Sacred Heart / Doctor communicated with Partners.

Sacred Heart release instructions said to go to Partners on Monday (12/21) and they would be waiting for them.

Monday - Aaron called ahead and left a message that they were on their way.
Arrived - Front Lobby said that she got his message and would call him.
We waited nearby for a call.
She called - (I was in a store) - what was communicated to me is that Partners said he needs to talk to DCYF - Stella - who is managing the whole case.

Next .. we left, stopped and did a little Christmas shopping, got back to their house, my mom's house in Hayden.

Next, I was there, less than hour and was leaving to pick up my child ..
And while I was there -

Someone shot out my window on my car.

Now note - I am 49 years old and have never in my life had anything like this happen. My mom's house is on a little tiny quiet loop that almost every house is retired people around 70-90 years old. It is very quiet and no one goes there that doesn't live there or have a person they are visiting or delivering to.

The police could not believe it happened there, they were shocked.

I have no idea if it is related but it is very bizarre and interesting timing.

Partners says that you are the one managing all of this so I am sending this to you.

Aaron is avoiding conflict.

It is Christmas.

Parenting Plan, Mom picks up kids at Noon on 12/24.

Aaron asked me to communicate with you that he would like to schedule a phone meeting with you next week, after Christmas, for understanding of what is currently not understood.

Everyone, every other agency, court, etc, points to you as the one who is responsible and manages all of the details.

Another note - the boys have been picked up from Mom with bruises, grab marks - nails and hand, finger print bruises - and black eyes MANY times since September 2017.

You also have on DCYF record from 2018, from DMS, interviewed by DCYF at his school - that Mom punches them with a closed fist.
I read that report.

2018 - Mom - Sirinya Surina - has police record of Child Neglect and Child Assault.
I think it is January and March.

Every agency points to another agency.

Court says they won't do anything unless DCYF says they need to do something.

DCYF says they can't do anything, only court can do something.

Police say - Family Court has to do something.

Family Court says if DCYF and Police don't do something, they won't do something.

Is it possible to get all of the authorities on the same page??? Can you help with that?
Please.

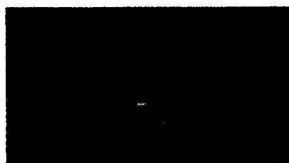

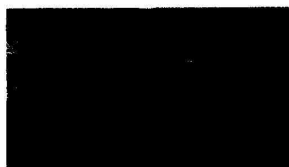
Also - DMS said, in 12/18 that his injuries were from 2 days ago (12/16)

Adding information -

Thursday 12/17 - when we were at Moms for Aaron to pick up the boys, AAS was standing at the door and saw Aaron. Sirinya was holding him back from the door.

DMS wasn't there.

On 12/18 - once Aaron got the boys, DMS was upset.

He said to us that Mom told him Dad came to pick him up on Thursday but since DMS wasn't there, Dad didn't want to wait for him and left without getting the boys.

DMS asked, why didn't you wait for me, why did you leave without me?

This was after Mom refused to exchange the kids on the court scheduled exchange time.
