My name is Karmen Colby. I am the aunt of DMS and AAS, sister to Aaron Surina. I have been present for most court hearings/matters and many child exchanges since August 2017.

On December 18, 2020, I was with Aaron Surina when he picked up his child, DMS from school.

Aaron had verified with the school that DMS's school day was over at 11:50am on 12/18/2020 and that he would be in 'Day Camp' after school got out.

Aaron sent messages on the Family Wizard to Sirinya that he was picking DMS up from school and would go to pick up AAS after.

When Aaron picked up DMS, DMS was very upset. He asked Aaron Surina (Dad) why Aaron didn't wait for him the previous day – 12/17/2020. Aaron and I asked DMS what he meant. DMS said that Mom said that Dad came to pick them up but that Dad didn't want to wait for DMS so Dad left without picking up the boys.

On 12/17/2020, Sirinya refused to give Aaron the boys on his court scheduled pick-up time.

Sirinya and her friend, Keith Landrus adamantly confirmed that Aaron was not getting the boys on 12/17/2020.

12/18/2020 – we waited hours to get AAS after Aaron picked up DMS from school after his school day ended.
