### I declare:

1. I am a Respondent and father of both children involved in these cases. I am bringing this motion before the court because of nearly a dozen of these instances which I have attempted to bring before the court on numerous occassions and have for one reason or another been unable to get them on the record. I feel along with my children that these crimes are serious and these behaviors are not normal or acceptable for a custodian to treat her children. The petitioner makes up her own rules and tries to sabotage Dad's relationship with his sons. The legislature addressed this behavior in Washington.

Sirinya has been given every opportunity to parent and show the court and those involved that she's the person her lawyer portrayed her to be. It is truly something that is hard to understand and does not make much sense...

- 2. The other party, Sirinya Polarj, did not obey the orders checked below that were signed by the court on the Dec 20, 2019 Court's orders outlining the following:
  - a. The parenting plan (Page 3 section 8), Dad's picks up on Thursday and Sirinya does not have two thursdays in a row.
  - b. The parenting plan (Page 5 section 12), Dad transports as the receiving parent picks up.
  - c. The parenting plan (Page 9, section 14 items (b), (m)), Do not speak disparigingly in front of the children and limit the exchanges to 5 minutes.
  - d. The parenting plan (Page 10 Lines 10, 11) outlines a warning foir committing custodial interference including being arrested.

## Parenting plan or residential schedule

Describe how the order was **not** obeyed including dates and times:

- On 10/01/2020, Mr. Surina arrived at the house on time and Sirinya refused the children or exchange by concealing removing both of their sons from the exchange location and concealing their whereabouts.
- This was intentional in denying access to their court ordered time with their father. She violated the orders outlined in the parenting plan once again and without remorse.
- The two boys were concealed and all contact with them blocked for the entire 5 day parenting schedule causing fear, uncertainty, emotional instability and an uncomfortable environment when Sirinya and her friends are around both boys.
- The continued conflict and negative conditions are harmful and the boys are showing signs of stress. This is an abusive use of conflict, much

#### REPORT DETAILS:

- Mother continues to cause emotional and psychological harm to children including denying any contact or relationship with their father and punishing them for missing their father. It's unacceptable to do to 4 and 8 year old boys.
- 1st degree custodial interference, taking children away from the house where receiving parent picks up to prevent children from having time with their father.

- ☐ Approve other reasonable orders, including ordering the other party to:
  - Pay a \$110 fine civil penalty (required for violations of parenting time orders),
  - Order a CR35 Evaluation / Accept proposed parenting plan reversed.
  - Order the AAPI-2 Adolescent Parenting examination with Linda Wirtz and the examination should take place without any friends or "translators" to speak or take the test or help with the test on her behalf. Sirinya's own commissioner Swennumson found the reports of Sirinya's abuse and neglect to be credible and ordered a GAL around March 2018.
  - Re-Designate parties as Petitioner and Respondent as the case has been used mainly to control and manipulate the respondent using privilege for over 3 years and losses are unacceptable and unnecessary.
  - Any other relief allowed by law (Chapter 9A.40 RCW, 7.21 RCW, Chapter 26.09 RCW, Chapter 26.10 RCW, Chapter 26.16, Chapter 26.26 RCW, and RCW 26.18.040).

### 6. Other orders requested (if any): ]

#### Requesting the court:

- 1) Accept the proposed parenting plan, Mr. Surina is prepared to take custody of his children if the court deems that appropriate under the circumstances. Their safety, comfort and wellbeing is of concern to the court and has been since 2018. None of those issues have been evaluated and were covered up as "already litigated". The issues have only exacerbated as outlined in the recent major crimes investigation of the petitioner and her mother that was sent to the prosecutors office.
- 2) Remove all restraining orders that the petitioner was able to pay to have placed on the parties children preventing the parties children from calling their family members or emergency services if theyRequesting the court r are not safe or there is an accident or emergency. Often the two boys are left with their grandmother whom has no english speaking ability and they are unable to hold a conversation. They are not comfortable and are often terrified to return to their mothers.

After a little while Aaron honked his horn but again no one came out to meet him. Aaron also received no response from phone calls or text messages aside from an earlier message from Siriniya stating that Aaron could not have the children today.
