Statements in the Objection	
	I disagree with what the other party said about this because Aaron's answer does not address the law. We had no prior agreements about relocating.
c. Contact	I disagree with what the other party said about this because disrupting the children's contact with me would be more harmful. Aaron's contact with our children will not be disrupted.
d. Limitations	I don't have enough information to agree or disagree with what the other party said about this. Aaron did not address this in his objection. He is subject to RCW 26.09.191 restrictions in our final parenting plan.
e. Reasons for moving	I disagree with what the other party said about this because my reasons for moving are in good faith. I would like more space, a permanent home, and security in where we live that you cannot find renting.
f. Reasons for objecting	I disagree with what the other party said about this because Aaron does not object in good faith. If the relocation is granted, I will be relocating to Cheney from Spokane. The children would not be isolated from anyone.
g. Child/ren	I disagree with what the other party said about this because I have never forced my children to work in my restaurant. I detail this accusation further in my declaration in support of my relocation.
h. Quality of life	I disagree with what the other party said about this because while some things may be unfamiliar at first, the children are still relocating a very short distance from their current life. This is also not what the law considers. The quality of life and resources available to our children and to myself are substantially the same in Spokane and Cheney.
i. Other arrangements	I don't have enough information to agree or disagree with what the other party said about this. Aaron did not answer this in his objection. No other arrangement is needed as I am requesting a relocation that is about fifteen minutes away from where I currently live. Aaron's relationship with our children will not be disrupted.
j. Alternatives	I disagree with what the other party said about this because Aaron's response does not address the law. My alternative is to forego a permanent home and continue to pay increasing rent. It is feasibly, but likely undesirable, for Aaron to relocate.
k. Financial	

Statements in the Objection

I don't have enough information to agree or disagree with what the other party said about this. The financial impact on me if the relocation is denied is large. I am requesting to relocate partially to lower my overall monthly costs. I am also moving for a better quality of life. If the relocation is granted, the financial impact on Aaron is minimal as the only difference will be our exchange commute.

I disagree with what the other party said about this because I am relocating a very short distance from my current home. A modification to our parenting plan is unsupported.

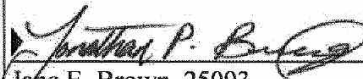

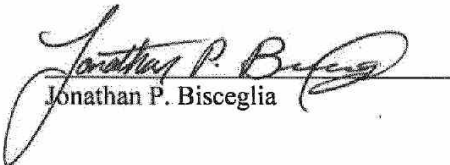
