Superior Court of the State of Washington, Spokane County

AND TO: All Parties in this Case

Pursuant to the Washington Rules of Evidence, Rule 201, Aaron Surina, the Respondent in the above-entitled matter, hereby requests the court to take judicial notice of the following facts, which are not subject to reasonable dispute:

## **School District:**

Both minor children, David and Andrew Surina, are students in the Spokane School
District. Andrew attends Jefferson Elementary School, and David attends Sacajawea Middle
School.

2. Spokane School District is their established school district and has been for their entire

public school tenure.

**Relocation Statutes:** 

Washington State's relocation statutes apply to this case. Washington is the home state

for the purposes of UCCJEA and this should be reflected in a parenting plan for custody

purposes.

Financial Responsibility as Relates to 42 USC 1301(10)(d):

4. Aaron Surina (the father) will assume complete financial responsibility for the

minor children, David and Andrew Surina as their custodian.

**Residential Addresses:** 

5. The residence for the petitioner is 227 E. 22<sup>nd</sup> Ave, Spokane, WA for the last few

years. Now the address temporarily located to for Sirinya Surina (the mother) is:

9120 Silver Ct, Cheney, WA according to recent filings with the court.

6. The residence for Aaron Surina (the father) is on Bernard Ave, Spokane, WA

Pick Up:

As of today's date September 13, 2023; Pick Ups and exchanges are ordered to

occur at the respective schools in Spokane School District or at the parties residences if

school is not in session in Spokane School District.

## **Truancy**

8. On 5 separate days since the hearing, September 5<sup>th</sup>, 2023, September 6<sup>th</sup>,

2023, September 7th, 2023, September 12, 2023, September 13th, 2023 The

Petitioner knowingly withheld our children from school in their established school district

in direct contempt of the current court's order, the current parenting plan and the

relocation statutes of Washington RCW 26.09.480.

9. On Thursday, September 7<sup>th</sup>, 2023, the petitioner intentionally withheld the minor

children from the respondent in violation of 9A.40.060 by not having them in school and

thus making the exchange inaccessible or unknown or outside of the court's order in

direct defiance of the order / parenting plan established in December of 2019 in

Spokane, WA.

**Potential Criminal Conduct:** 

10. Petitioner with intent to deprive the respondent and the Spokane School District

of lawful court ordered time and physical custody, intentionally withheld both children

from school and from the exchange after school in direct violation of a court's order and

RCW 9A.40.060.

Correspondence

11. The Petitioner advised Spokane school district authorities at Hutton Elementary

on May 30th 2023 in an email that she had moved to Cheney and that the parties oldest

son would be going to Westwood m idle school.

- 12. The petitioner did pick up the children on September 11, 2023 following the court order, from their schools in Spokane School district on her first day of picking them up for the school year. She picked up Andrew from Jefferson at 3pm and David from Sacajawea at 3:30pm as the parenting plan states. She did not return them to school September 12<sup>th</sup> or September 13<sup>th</sup> in direct defiance of the law and the parenting plan.
- 13. The petitioner now has caused a petition for truancy to be sent to the court for unexcused absences. Today marks the 5<sup>th</sup> absence within 10 days which activates a petition sent to the court on behalf of the children by the school district for truancy under the Becca Law.
- 14. The petitioner was a stay at home mother with imputed income in December 2019 when the parenting plan was drafted.
- 15. The petitioner is no longer a stay at home mother without a job.
- 16. The petitioner's purchase of the residence at 9120 Silver in Cheney was for 565,000.00 according to online public records and escrow closed on May 23, 2023.
- 17. The house located at 227 E. 22<sup>nd</sup> ave, Spokane, WA was listed for rent exactly 30 days after escrow closed. On Zillow.com it shows listed for rent on 6/23/2023.
- 18. After the email of petitioner telling school authorities that she had moved, she told the court that she had not moved and was not moving yet.
- Snowden Elementary School and Westwood Middle School are both in Cheney School
   District.

The Respondent respectfully requests that these matters be judicially noted as they are not subject to reasonable dispute and can be accurately and readily determined from sources whose accuracy cannot reasonably be questioned.
