5 **Violations Highlighted in the Correspondence**

6 **Custodial Interference:** Retaining or withholding my children and refusing to let
7 me pick up my children from their schools in Spokane as specified in the parenting plan
8 intentionally to deprive me of my court ordered parenting time with my children.

10 **Violation of Court-Ordered Parenting Plan:** Unilaterally changing my children's
11 schools without any notice, discussion, consent or a court order.

12 **Direct Opposition to Judicial Orders:** Intentionally acting against previous court
13 orders including June 23, 2023 that require adherence to the parenting plan.

14 Given the gravity of this situation, I urgently request that this evidence, complete
15 with the required oath of authenticity, be admitted into the court record for immediate
16 consideration in the pending legal proceedings. These actions not only violate the
17 court's orders but also infringe upon my constitutionally protected rights as a father.

As for pick up tomorrow, you can pick them up at my house after court I have family here that will pick them up or you can pick them up at school. Let me know

Where are the kids? You're refusing to allow them to be in school according to the parenting plan and you're intentionally retaining them from me on my pickups.

I do not agree with the kids being relocated to the schools there. It's too disruptive and they don't want to go.

Where do I go to pick up our kids tomorrow? I go to their schools, which currently are in the Spokane school district.

Are you going to have them there for pickup tomorrow at Jefferson and Sacajawea?

I have to have their aunt pick them up since we're in court tomorrow. Let me know what to expect please
