DECLARATION OF: SIRINYA SURINA IN SUPPORT OF CONTEMPT MOTION

### Sirinya Surina Declares:

- 1. I am the Petitioner and mother of David and Andrew Surina;
- I received the attached text message (Exhibit A) just hours after the court entered our temporary order restricting our contact to written communication about the children only.
   Aaron complained about the cost of the legal action and offered to "help" me.
- 3. We agreed to a Thursday visit for Aaron due to the late finish of our Hearing on Wednesday, September 27, 2017. Aaron began immediately to insist on his version of the court order with regard to exchanging the children at the school. (Exhibit B) He also used the occasion of exchanging the children to berate me about "working together", not wanting to share the children and that our "lawyers want us not agree."
- 4. On September 29, 2017 at 7:39 a.m. Aaron started pressuring me to change our parenting plan. (Exhibit C, a true and correct copy of Aaron's email)

- 5. On October 2, 2017 at 2:03 p.m. (Exhibit D) Aaron informed me about doctor's appointments he had set for Andrew and David without consulting me. I took the children to their appointments at a later date where they received their immunizations and check ups. He also tried to set up a counseling session without consulting me, with a counselor that I did not agree to.
- Aaron also pressured me to enroll Andrew into KinderCare Learning Center, a fulltime daycare, for our 14 month old. Even though we had planned for me to open a daycare before we separated.
- 7. On October 2, 2017 at 3:39 p.m. (Exhibit E) Aaron once again emailed me about settling our parenting plan under the guise of "communicating via writing about the children only." His email was about settlement and not about our children's medical appointments or exchanges as ordered by the court. When I get these emails, I don't know how to respond and need to call my attorney, which cost me more money.
- 8. I attempted to exchange the boys on Friday, September 29<sup>th</sup>, but Aaron came early to the exchange and wanted to exchange the boys at 3:00 p.m. even though David is not released from school until 3:15 p.m. A fact Aaron was aware of on the day we entered the temporary order. He ignored the "curb side exchange" part of the order and arrived early at the school.
- Additionally, he drove onto my premises on the next exchange with the boys and parked in our driveway, where he could not be seen from the front door.
- 10. I communicated with Aaron that I did not want to continue the exchanges at the school. My attorney communicated to Aaron's attorney that I did not agree to bring Andrew to the school for Friday exchanges. Especially due to Aaron's ignoring the boundaries set by the court. Aaron once again insisted on his version of the court order and refused to make the exchange at our residence curbside.
- 11. On Friday, October 13, 2017, Aaron came almost a half hour early to Aaron's school to pick him up. Even though he knew Andrew would not be there for an exchange. He did not wait in the parking lot to do a curbside exchange, but went into the school and whisked David away from me and out to his car. He then drove to my house where he picked up Andrew curbside.

12. In August 2017, we enrolled David to attend ½ day Kindergarten on Monday through Thursday. He gets out at 11:30 a.m. during the week. On Friday he is released at 3:15 p.m. Aaron is fully aware of David's school schedule. On Wednesday, October 18, 2019, Aaron sent me a text message, (Exhibit F, a true and correct of Aaron's text message to me) acting as if David was attending Kindergarten for the full day. He insisted that the exchange was supposed to be at the school. The court ordered Wednesday pickup at my house at 3:30 p.m. with a return at 7:00 p.m. Aaron showed up almost ½ hour late. He took the children to the hospital to falsely accuse me of beating Andrew. After Aaron was almost 1 ½ hours late, we started calling hospitals. We discovered that Andrew had been checked into Sacred Heart Hospital. I sent Aaron an email to ask him why Andrew was checked in at the hospital. (Exhibit G, a true and correct copy of my October 18, 2017 email thread) When he didn't respond, I called crime check. He did not return Andrew and David until almost 10:00 p.m. Police came to my house before Aaron arrived to look around and interview me. When Aaron arrived, the police went out and talked to Aaron. They came back to the house and asked if I could get some clothes for Aaron to wear to work. I went to the garage and bagged up 3 shirt jackets and some socks. The police finally left around 10:40 p.m.

- 13. I want David to come home after school on Friday when he is scheduled to spend the weekend with his Dad to allow me to say good bye and encourage him
- 14. When the court outlined a weekend schedule and exchange times allowed that we "may exchange the children on Friday at the school." After we tried the first Friday exchange, I gave Aaron notice that I did not agree to continue the Friday exchange at the school.



If one parent is sick or has something for work, or any need, let's work together for what our children need. If a child needs something, let's communicate and work together.

Child Support is set already. That is what it is.

Now we can move forward.

Can we make a schedule that is good for our children?

And also allows us as parents to be the best we can be for our children?

This is my proposal -

50/50

Friday to Friday

With 2 one on one afternoon / dinners each week, one with each child, with each parent. Both children and both parents will have an afternoon and evening 1 on 1 with each child. We can be flexible with this.

It is a bonus that we can give to our children.

I think this is important for all of us but perhaps we should wait 2 weeks to add this while we all adjust. We can communicate about this together. Let me know what you think.

Switch Parents at the end of the school day on Friday.

Let's call it Parent On, Parent Off and Switch.

SKHIBIT E

Parent On picks up children from school on Friday and has them through dropping them off at school the next Friday.

'Parent On' means who the children are staying with for the week, who is primarily responsible to take care of them, get them to school, pick them up from school.

'Parent Off' is who the children are not staying with for the week but still available.

Switch - Primary Responsibility switches to the other parent for the week. Parents switch from 'Parent On' to 'Parent Off'

#### Friday Switch Parents

- Friday Morning Parent ON drops off children to school.
- 11:30am Friday parenting switches to other parent.
- End of school day NEW Parent On picks up children from school.

#### One on One afternoons.

The school week with each parent is Monday-Thursday and Friday Morning.

Friday is the switch day.

Tuesday and Wednesday are the middle of the week.

We both miss our kids.

#### One on One afternoons

Tuesday - David - Parent Off picks up David from school for a 1 on 1 afternoon and evening.

Parent On has 1 on 1 with Andrew.

Parent Off returns David to Parent On at 7pm.

We can be flexible where we meet but need to choose a set drop off place.

Wednesday - Andrew - Parent Off picks up Andrew from school for 1 on 1 afternoons and evening Parent On has 1 on 1 with David.

Parent Off returns Andrew to Parent On at 7pm.

With both children in school, our Parent Switches would be done by the new 'Parent On' picking the children up from school as the other parent would have dropped them off at school for the start of their school day.

I think this schedule is the most fair and reasonable that we can do for our children and each other. Having them both in school will give them stability and not switching them back and forth during their school week is in their best interest. They will have weekend transitions with each parent before their next school week.

I want to help you have a schedule that allows you to do the things you noted you intend on doing such as taking classes and pursuing employment.

I hope that we can focus our attention on working together to give our children the best that we are able. We don't need to fight anymore.

I hope we can be flexible to work together. I intend on doing so.

#### The bonus - 1 on 1 afternoons.

If the Parent Off can't make it, the Parent On is responsible and will pick up the child as the other days their week but there must be confirmed communication of change to the Bonus afternoons.

We will need to address holidays and special days.

Again, let's work together

If there is a special event one of us wants to bring one or both children to, we just need to communicate with each
