To the person receiving this motion:

If you do not agree with the requests in this motion, file a statement (using form FL All Family 135, *Declaration*) explaining why the court should not approve those requests. You may file other written proof supporting your side, and propose your own *Parenting Plan* or *Child Support Worksheets*.

If the court grants an *Immediate Restraining Order* without notice to you, you can file a motion to change or terminate it before the hearing date. (Civil Rule 65(b).) There is no pattern form for that motion.

1. I am the: Petitioner. I am asking for an Immediate Restraining Order against my spouse.

I want my children under 18 to be protected by the order:

2. I ask the court to approve an *Immediate Restraining Order* to protect me and/or my children. Without this Order, my children or I could be hurt or suffer damage or loss immediately. This harm could be irreparable.

Respondent, Aaron Surina, has recently moved his mother into our residence. They have combined together to terrorize me and to turn my oldest child, David against me. They have taken David, our oldest child, from our residence and do not return with him until very early the next day. Aaron has his mother watch David while he goes to work. He refuses to tell me where he keeps David when he takes him. Recently they tried this same tactic with our youngest son Andrew. They took him with them and returned him dirty and hungry and exhausted.

Two weeks ago, Aaron brought David home about 1:00 a.m. Aaron was drunk. He had another man with him, who was also drunk. He was apparently driving our car while intoxicated.

He got me out of bed, woke up Andrew and my mother and started to verbally abuse me. He had his drunken friend take video of me in my nightgown. When I asked him why he brought a stranger into our home, he said, "This is my house and not yours and he can do "what he wants." I became upset and yelled back at him so he called the police. His friend also started to verbally abuse me. Aaron supported him and didn't defend me. He told the police that I "terrorized" him and he was afraid I might hurt him. I'm 5'2" and 130 lbs. Aaron is over 6' and about 270 lbs.

In the recent past he has he grabbed my phone and threw it at the wall and broke it. He shoved me onto the couch, spit on my face then put his big bare feet on my face. He was screaming at me telling me everything in the house was his and he could do whatever he wanted because he bought it. He paid for it. He said he can do whatever he wants because he's big and I'm small.

On another occasion, Aaron got angry, grabbed my phone out of my hand and threw it, breaking the second phone. He pushed me down, pulled my hair and slapped me in the face. I tried to run away from him but we were in our bedroom and I had to fight back.

Presently, when he yells at me and pushes me around or verbally abuses me, I am very afraid that he will injure or kill me. He's a very big man and I'm only a little person. He has weapons in the house but until now has never threatened me with them. But he frightens me. I'm a prisoner in our home and if he wants to, or gets too wound up on alcohol or marijuana, I'm afraid that he will totally lose control and cause our children and me serious physical injury.

Aaron has had past prescriptions for ADHD. I don't know if he is still taking it but I do know he has daily habits including cannabis, alcohol and chewing tobacco. He needs his prescription medicine but prefers alcohol and marijuana.

Please also see Declaration Of: Sirinya Surina In Support Of Temporary Order And Restraining Order filed contemporaneously with this Motion.

3. Notice:

I should **not** have to notify the other side in advance that I am filing this *Motion* because my children or I could be harmed beyond repair if I gave any advance notice.

Aaron has threatened to take our children and hide them away from me in Idaho at his sister's residence. His mother has moved into our residence to assist him should he decide to take the children out of our home. He has physically abused me in the past and I fear that he will do me bodily harm if he receives advance notice of this *Motion*.

4. Court hearing request

I ask the court to approve an *Immediate Restraining Order* now, and hold a hearing within 14 days to consider all of my requests for temporary orders listed below. I will have my spouse served with notice of the hearing so the court can hear his side.

5. Active duty military

My spouse is not covered by the state or federal Service Members Civil Relief Acts.

I ask the Court to approve these orders immediately:

6. Do not disturb

Order my spouse not to disturb my peace or the peace of any child listed in 1.

7. Stay away

Order my spouse:

Not knowingly to go or stay within 2 city blocks of my home, workplace, or school, or the daycare or school of any child listed in 1.

To stay away from my home, workplace, or school, and the daycare or school of any child listed in 1.

My spouse and I: live together.

8. Do not hurt or threaten

Order my spouse/domestic partner not to:

- Assault, harass, stalk or molest me or any child listed in 1; or
- Use, try to use, or threaten to use physical force against me or the children that would reasonably be expected to cause bodily injury.

Warning! If the court extends this order after a full hearing, the court must consider if weapons restrictions are required by state law; federal law may also prohibit the Restrained Person from possessing firearms or ammunition.

9. Surrender weapons

No request.

10. Protect children

Order my spouse not to take the children listed in 1. out of Washington State.

Order that the children in 1. will live with: me until the hearing.

11. Protect property

Order: both parties not to move, take, hide, damage, borrow against, sell or try to sell, or get rid of any property, unless it is a usual business practice or to pay for basic necessities. (If the court makes this order, both spouses must notify each other about any expenses that are out of the ordinary).

12. Do not change insurance

Order: my spouse not to make changes to any medical, health, life, or auto insurance policy that covers either spouse or any child listed in 1. That means s/he must not transfer, cancel, borrow against, let expire, or change the beneficiary of any policy.
